**Industrial Production Index. Base 2000
July 2007**

**The Industrial Production Index adjusted for calendar effects
increases 1.3% in July as compared to the same month in 2006**

The General Industrial Production Index (IPI) experienced a 4.0% variation in July 2007 in comparison with the same month the previous year. After adjusting for calendar effects, the interannual variation of the IPI was estimated at 1.3%.

By economic destination of the goods, the variation rates with respect to the same month from the previous year were 6.2% for consumer goods (8.5% for durable consumer goods and 5.7% for non-durable consumer goods), 9.8% for capital goods, 2.4% for intermediate goods and -3.8% for energy.

After adjusting for calendar effects, these interannual rates were estimated at 2.8% for consumer goods (3.8% for durable consumer goods and 2.4% for non-durable consumer goods), 7.0% for capital goods, -0.3% for intermediate goods and -4.6% for energy.

The average rate of the IPI adjusted for calendar effects increases 3.1% in the first seven months of 2007

The average IPI rate stood at 3.5% during the first seven months of 2007 in comparison with the same month of 2006. After adjusting for calendar effects, this average rate stood at 3.1%.

The evolution of the average industrial production rate by economic destination of the goods was 4.0% for consumer goods (10.6% for durable consumer goods and 2.9% for non-durable consumer goods), 7.4% for capital goods, 2.8% for intermediate goods and -1.4% for energy.

After adjusting for calendar effects, these average rates for the seven first months stood at 3.5% for consumer goods (9.9% for durable consumer goods and 2.4% for non-durable consumer goods), 7.0% for capital goods, 2.3% for intermediate goods and -1.5% for energy.

Activities with the greatest growth in the January-July 2007 period were "Manufacture of furniture; manufacturing n.e.c.", 13.3%, and "Manufacture of electrical machinery and material", 12.4%.

In contrast, those with the lowest growth were "Manufacture of office machinery and computers", -15.9%, and "Tanning and dressing of leather; manufacture of luggage, handbags, saddlery, harness and footwear", -8.3%.
