

**Industrial Production Index. Base 2000
September 2008**

**The Industrial Production Index adjusted for calendar effects
decreases 8.8% in September as compared to the same month in
2007**

The General Industrial Production Index (IPI) experienced a -4.5% variation in September 2008 in comparison with the same month the previous year.

After adjusting for calendar effects, the interannual variation of the IPI was estimated at -8.8%.

By economic destination of the goods, the variation rates with respect to the same month of 2007 were -2.7% for Consumer goods (-11.3% for Durable consumer goods and -1.2% for Non-durable consumer goods), -0.8% for Capital goods, -9.5% for Intermediate goods and -0.6% for Energy.

After adjusting for calendar effects, these interannual rates were estimated at -8.6% for Consumer goods (-18.8% for Durable consumer goods and -6.4% for Non-durable consumer goods), -5.0% for Capital goods, -14.1% for Intermediate goods and -2.0% for Energy.

**The average rate of the IPI adjusted for calendar effects decreases 3.8% in the
interannual rate in the first nine months of 2008**

The average IPI rate stood at -3.7% during the first nine months of 2008 as compared with the same period of 2007. After adjusting for calendar effects, this average rate stood at -3.8%.

The evolution of the average industrial production rate by economic destination of the goods was -3.8% for Consumer goods (-10.7% for Durable consumer goods and -2.6% for Non-durable consumer goods), -1.4% for Capital goods, -7.3% for Intermediate goods and 2.8% for Energy.

After adjusting for calendar effects, these average rates for the nine first months stood at -4.0% for Consumer goods (-11.2% for Durable consumer goods and -2.6% for Non-durable consumer goods), -1.5% for Capital goods, -7.4% for Intermediate goods and 2.8% for Energy.

The activities with the greatest growth in the January-September 2008 period were *Manufacture of electronic material; manufacture of radio, television and communication equipment and apparatus*, with 21.1%, and *Manufacture of other transport material*, with 12.0%.

In contrast, those with the least growth were *Manufacture of other non-metallic mineral products*, with -18.1%, and *Manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials*, with -17.8%.
