Industrial Production Index. Base 2005 September 2009

The Industrial Production Index adjusted for calendar effects decreases 12.5% in September as compared with the same month in 2008

The General Industrial Production Index (IPI) experienced a -12.5% variation in September 2009 in comparison with the same month the previous year.

After adjusting for calendar effects, the interannual rate of the IPI also registered a decrease of -12.5%.

By economic destination of the goods, the variation rates with respect to the same month the previous year were -5.7% for Consumer goods (-25.8 for Durable consumer goods and -2.2% for Non-durable consumer goods), -15.7% for Capital goods, -17.9% for Intermediate goods and -6.9% for Energy.

After adjusting for calendar effects, these interannual rates stood at – 5.7% for Consumer goods (-25.9% for Durable consumer goods and –2.3% for Non-durable consumer goods), -15.7% for Capital goods, –17.9% for Intermediate goods and -6.9% for Energy.

The average rate of the IPI adjusted for calendar effects decreases 18.8% in the interannual rate in the first nine months of 2009

The average IPI rate stood at -19.1% during the first nine months of 2009, in comparison with the same period of 2008. After adjusting for calendar effects, this average rate stood at -18.8%.

The evolution of the average industrial production rate by economic destination of the goods was -10.7% for Consumer goods (-31.7% for Durable consumer goods and -7.1% for Non-durable consumer goods), -25.6% for Capital goods, -25.6% for Intermediate goods and -8.5% for Energy.

After adjusting for calendar effects, these average rates for the first nine months stood at -10.3% for Consumer goods (-31.6% for Durable consumer goods and -6.7% for Non-durable consumer goods), -25.3% for Capital goods, - 25.3% for Intermediate goods and -8.5% for Energy.

The only activity that experienced an increase during the January-September period was *Manufacture of basic pharmaceutical products*, with a rate of 0.8%. In contrast, the activities that experienced the most moderate decreases were *Food industry*, with –1.4%, and *Chemical industry*, with –5.4%.

The activities that experienced the greatest decreases were *Manufacture of motor vehicles, trailers and semi-trailers*, with –36.9%, and *Manufacture of furniture*, with –34.0%.
