**Industrial Production Index. Base 2005
October 2009**

**The Industrial Production Index adjusted for calendar effects
decreases 9.2% in October as compared with the same month in 2008**

The General Industrial Production Index (IPI) experienced a -12.9% variation in October 2009 in comparison with the same month the previous year.

After adjusting for calendar effects, the interannual rate of the IPI also registered a decrease of 9.2%.

By economic destination of the goods, the variation rates with respect to the same month the previous year were -10.0% for Consumer goods (-27.9 for Durable consumer goods and -7.0% for Non-durable consumer goods), -16.0% for Capital goods, -15.2% for Intermediate goods and -8.0% for Energy.

After adjusting for calendar effects, these interannual rates stood at -5.3% for Consumer goods (-21.5% for Durable consumer goods and -2.5% for Non-durable consumer goods), -12.4% for Capital goods, -11.4% for Intermediate goods and -6.7% for Energy.

**The average rate of the IPI adjusted for calendar effects decreases 17.9% in the
interannual rate in the first ten months of 2009**

The average IPI rate stood at -18.5% during the first ten months of 2009, in comparison with the same period of 2008. After adjusting for calendar effects, this average rate stood at -17.9%.

The evolution of the average industrial production rate by economic destination of the goods was -10.6% for Consumer goods (-31.3% for Durable consumer goods and -7.1% for Non-durable consumer goods), -24.9% for Capital goods, -24.6% for Intermediate goods and -8.5% for Energy.

After adjusting for calendar effects, these average rates for the first ten months stood at -9.8% for Consumer goods (-30.2% for Durable consumer goods and -6.3% for Non-durable consumer goods), -24.2% for Capital goods, -23.9% for Intermediate goods and -8.5% for Energy.

The activities that experienced the most moderate decreases during the January-October period were *Manufacture of basic pharmaceutical products* (-0.4%), *Food industry* (-1.6%), and *Chemical industry* (-5.3%).

The activities that experienced the greatest decreases were *Manufacture of motor vehicles, trailers and semi-trailers* (-34.1%), and *Manufacture of furniture* (-33.4%).
