Industrial Production Index (IPI). Base 2005 October 2012. Provisional data

The annual variation of the Industrial Production Index stands at 0.6% in October, as compared with –12.1% in September

The annual rate of the IPI, adjusted for the calendar effect, stands at -3.3% in October, as compared with -7.5% in September

Annual evolution of industrial production

The Industrial Production Index (IPI) experienced an annual variation of 0.6% in October, more than 12.5 points above that registered in August.

The consumer goods sectors, durable and non-durable, and energy, registered positive annual rates. Those that most influenced were:

• **Energy**, with a variation of 5.8% and an effect of 0.820 on the general index, mainly, due to the positive evolution of the activities of *Refined of petroleum* and *Production, transport and distribution of electricity.*

• **Non-durable consumer goods**, with a rate of 2.4% and an effect of 0.687. Almost the half of the activities comprising this sector increase their productions. Among them, worth noting the *Processing and preserving of fruit and vegetables* and *Manufacture of pharmaceutical specialties*. Conversely, among the drops highlighted the activity of *Graphic arts and related services*.

In turn, the sectors with negative influenced on the general index were:

• **Capital goods**, with an annual variation of -2.5% and an effect of -0.484 on the general index. The activities most influenced in the negative evolution were the *Manufacture of motor vehicles* and *Manufacture of metal elements for construction*.

• Intermediate goods, with an annual rate of -1.1% and an effect of -0.372. The activities most influenced in this drop were the *Manufacture of basic iron and steel and of ferro-alloy products* and *Manufacture of elements made of concrete, cement and plaster*. Conversely, the *Manufacture of chemicals and chemical products* presented an important increase in its production.



Monthly rate evolution¹

The variation rate for October as compared with September 2012 was 9.4%, the highest registered in the last five years.

¹ In order to contribute to the analysis and interpretation of data, this section has been added with performance of the monthly IPI rate in October for recent years. The intermonthly rates of this type of series may have some degree of seasonal behaviour, therefore it is recommended that it be evaluated in relation to the item of data for the same month in previous years.



Year-to-date average rates

The average for the Industrial Production Index registered a variation of **-5.6%** in the first ten months of 2012, as compared with the same period the previous year.

By economic destination of the goods, this rate was negative in Capital goods (-10.9%), Durable consumer goods (-10.8%), Intermediate goods (-6.9%) and Non-Durable consumer goods (-3.1%). Conversely, was positive in Energy (1.1%).


Annual and average rates of the IPI General index and by economic destination

Annual evolution of the IPI

After correcting the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the IPI in the month of **October** was **-3.3%**, four points higher than that registered in September.




Results by Autonomous Community. Variation rates.

In October, eight Autonomous Communities registered positive annual rates in industrial production. The highest were registered in Cataluña (6.6%), Canarias (6.0%) and Comunitat Valenciana (5.9%).

In turn, Principado de Asturias (-14.5%), Castilla-La Mancha and Comunidad de Madrid (both with -9.6%) presented the lowest annual rates.
