**Industrial Production Index. Base 2000  
December 2007**

**The Industrial Production Index adjusted for calendar effects  
decreases 2.4% in December as compared to the same month in  
2006**

The General Industrial Production Index (IPI) experienced a 0.3% decrease in December 2007 in comparison with the same month the previous year. After adjusting for calendar effects, the interannual variation of the IPI was estimated at -2.4%.

By economic destination of the goods, the variation rates with respect to the same month from the previous year were -2.5% for consumer goods (-5.4% for durable consumer goods and -2.0% for non-durable consumer goods), 3.2% for capital goods, -2.8% for intermediate goods and 4.4% for energy.

After adjusting for calendar effects, these interannual rates were estimated at -5.1% for consumer goods (-8.8% for durable consumer goods and -4.6% for non-durable consumer goods), 1.1% for capital goods, -5.0% for intermediate goods and 3.6% for energy.

**The average rate of the IPI adjusted for calendar effects increases 1.9% in 2007**

The average IPI rate stood at 2.3% in 2007 in comparison with the same period in 2006. After adjusting for calendar effects, this average rate stood at 1.9%.

The evolution of the average industrial production rate in 2007 by economic destination of the goods was 1.8% for consumer goods (5.5% for durable consumer goods and 1.1% for non-durable consumer goods), 6.2% for capital goods, 1.3% for intermediate goods and 0.7% for energy.

After adjusting for calendar effects, these average rates in 2007 stood at 1.2% for consumer goods (4.8% for durable consumer goods and 0.6% for non-durable consumer goods), 5.8% for capital goods, 0.8% for intermediate goods and 0.5% for energy.

Activities with the greatest average growth in the year 2007 period were *Manufacture of machinery and equipment n.e.c.*, 10.2%, and *Manufacture of furniture; manufacturing n.e.c.*, 7.4%.

In contrast, those with the least growth were *Manufacture of office machinery and computers*, -12.2%, and *Tanning and dressing of leather; manufacture of luggage, handbags, saddlery, harness and footwear*, -8.4%.
