Industrial Price Index (IPRI). Base 2005
February 2010. *Provisional data*

Main Results

- The **interannual** variation rate of the IPRI for the month of February increases two tenths and stands at **1.1%**.
- The **monthly** variation of the general index is **0.2%**.
- Six **Autonomous Communities** register **negative interannual** rates in February, with **Principado de Asturias** (**-3.8%**) being of particular note.
- **Canarias** experiences the highest interannual variation rate, with **6.5%**.

Interannual variation rates

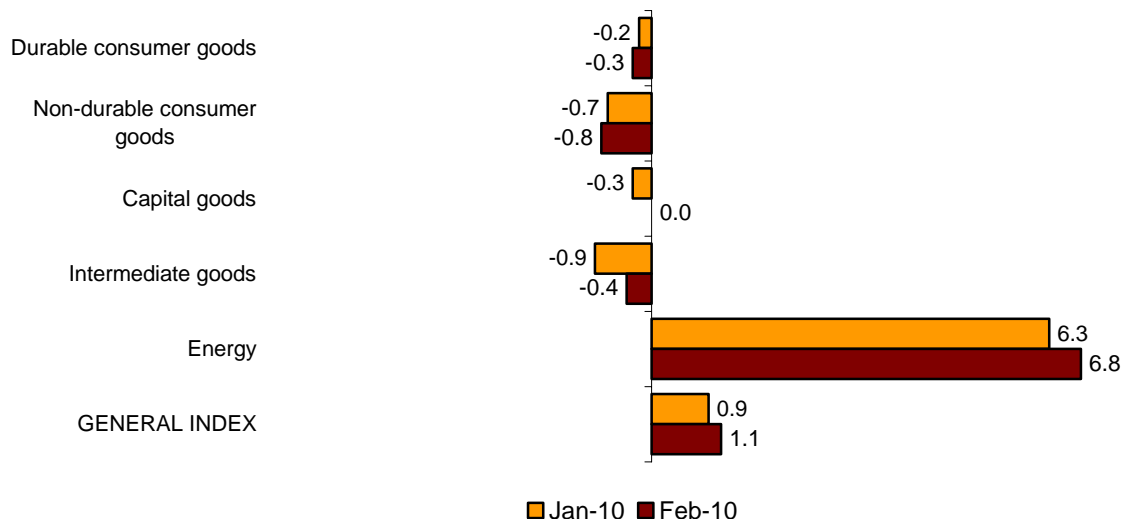
The interannual rate for the general Industrial Price Index (IPRI) in February was 1.1%, two tenths more than that registered in January.

By economic destination of the goods, the industrial sectors that most influenced this increase in the annual rate were:

- **Intermediate goods**, whose annual variation increased five tenths, standing at **-0.4%**, mainly due to the rise in the prices of *Manufacture of basic chemical products, nitrogen compounds, fertilisers, plastics and synthetic rubber in primary forms, Manufacture of plastic products and Manufacture of pulp, paper and cardboard* as compared with the drop they experienced in February last year.
- **Energy**, whose annual rate stood at **6.8%**, five tenths more than that registered in January. This increase was primarily due to the increase in the prices of *Refined petroleum and Production, transport and distribution of electrical energy*.
- **Capital goods**, which increased their annual rate three tenths, and reached 0.0% in February 2010. Of note in this variation was the rise in prices of *Manufacture of metal elements for construction*, which remained stable in February 2009.

Monthly variation rates

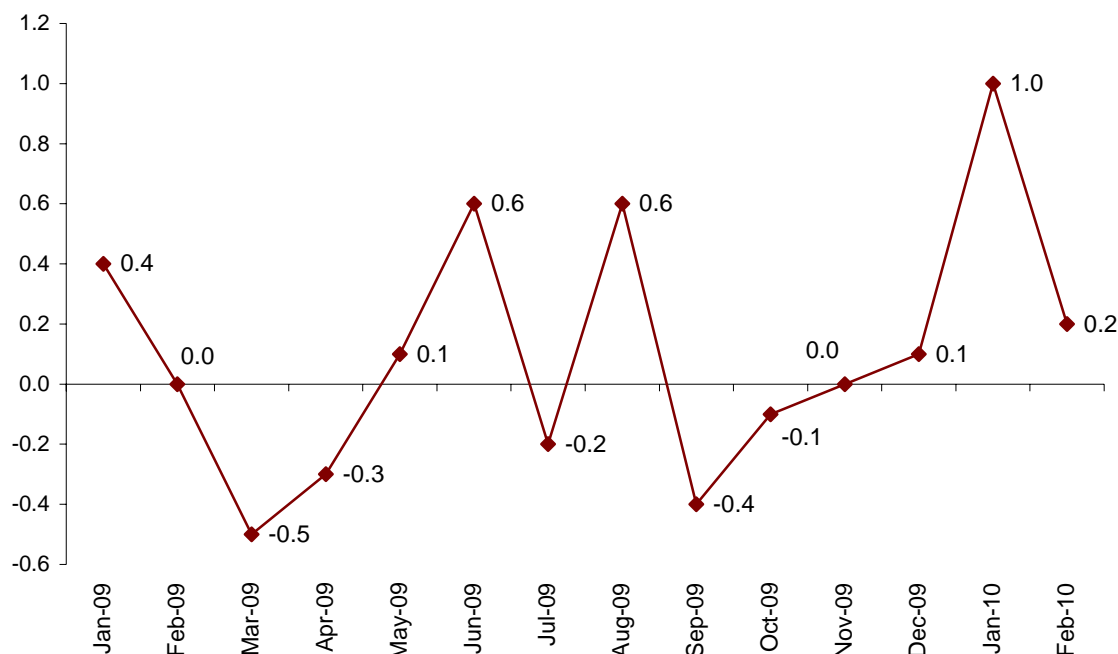
In February, the monthly variation of the IPRI was **0.2%**.

By economic destination of the goods, all of the industrial sectors had a positive monthly effect, except *Non-durable consumer goods*, whose prices experienced no variation. Worth noting among them were the following:

- **Energy**, with a monthly variation of **0.4%**, contributed **0.092**. This variation was largely due to the rise in prices of *Production, transport and distribution of electrical energy* and of *Refined petroleum*.
- **Intermediate goods**, whose monthly variation stood at **0.3%**, reflecting the price increases of the majority of their components, among which *Manufacture of basic chemical products, nitrogen compounds, fertilisers, plastics and synthetic rubber in primary forms* and *Manufacture of plastic products* were of particular note. Their contribution to the general index was **0.088**.

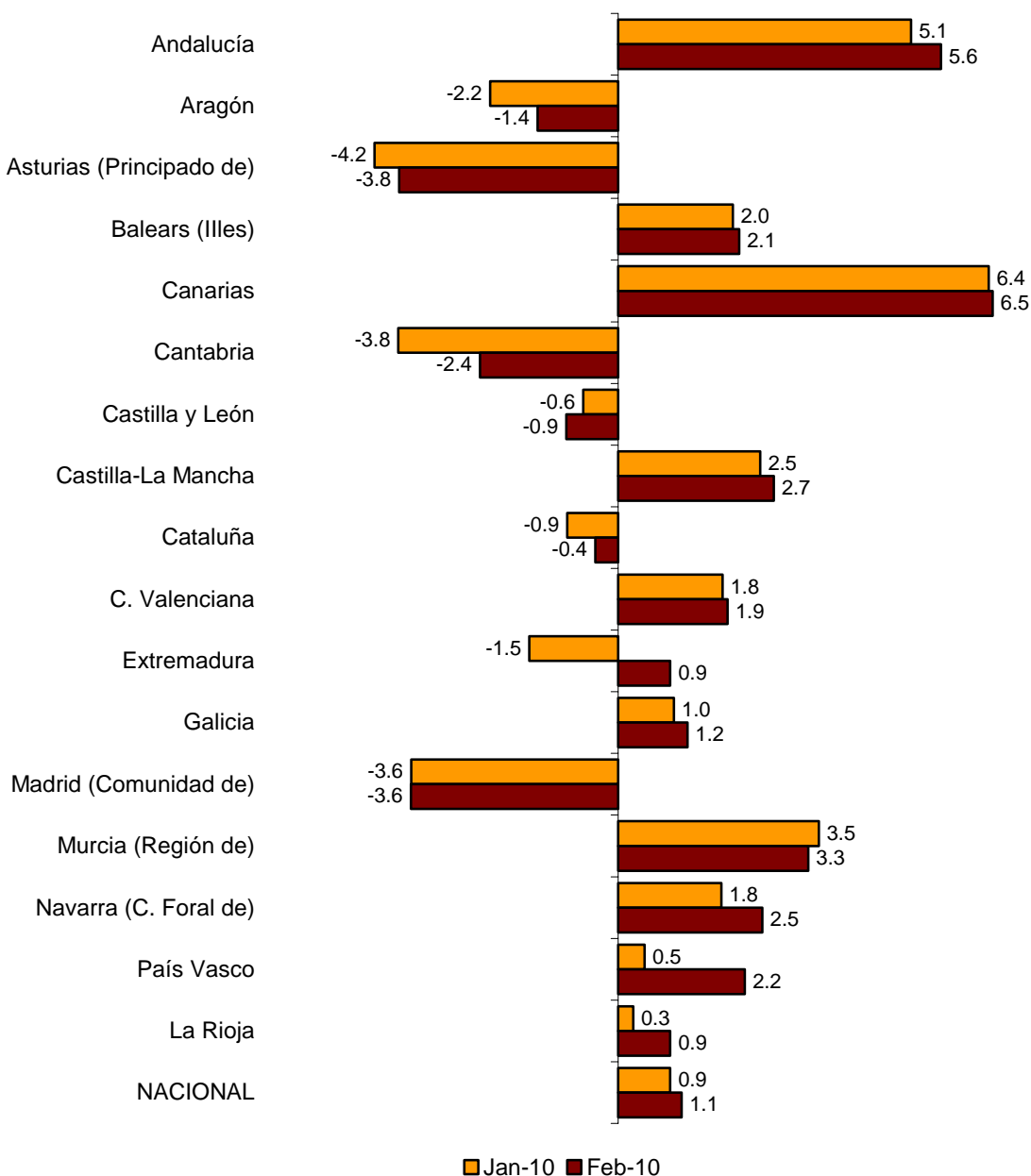
Results by Autonomous Community. Interannual variation rates

The greatest increases in annual variation corresponded to the Autonomous Communities of Extremadura (2.4 points), País Vasco (1.7 points) and Cantabria (1.4 points), whose rates stood at 0.9%, 2.2% and –2.4%, respectively.

Conversely, the only Communities whose annual rates decreased were Castilla y León (3 tenths) and Región de Murcia (2 tenths), standing at –0.9% and 3.3%, respectively.
