## Industrial Price Index (IPRI). Base 2005 March 2010. Provisional data

#### **Main Results**

- The **interannual** variation rate of the IPRI for the month of March increases more than one point and stands at **2.4%**.
- The monthly variation of the general index is 0.8%.
- Five **Autonomous Communities** register **negative interannual** rates in March, with **Principado de Asturias** (-3.8%) being of particular note.
- Canarias experiences the highest interannual variation rate, with 8.3%.


#### Annual evolution of industrial prices

The interannual rate for the general Industrial Price Index (IPRI) in March was **2.4%**, one point more than that registered in February.

By economic destination of the goods, the industrial sectors that most influenced this increase in the annual rate were:

- *Energy*, whose annual rate stood at **10.3%**, three-and-a-half point above that registered in February. This increase was primarily due to the increase in the prices of *Refined petroleum* as compared with the drop they experienced in March last year.
- *Intermediate goods*, whose annual variation increased eight tenths, standing at **0.4%**, mainly due to the rise in the prices of Manufacture of basic products in iron, steel and ferroalloys which decreased in March 2009.
- **Non-durable consumer goods**, which increased their annual rate seven tenths, and reached **-0.1%** in March 2010. Of note in this variation were the rise in prices of *Processing and preserving of meat and production of meat products* and the drop of *Manufacture of oils, vegetables fats and animals*.

#### Monthly variation of Industrial price

In March, the monthly variation of the IPRI was 0.8%.

By economic destination of the goods, the industrial sectors with the greatest positive monthly effect on the general index were the following:


- *Energy*, with a monthly variation of **2.3%**, contributed **0.534**. This variation was largely due to the rise in prices of *Refined petroleum*.
- Intermediate goods, whose monthly variation stood at 0.4%, reflecting the price increases of the majority of their components, among which Manufacture of basic products in iron, steel and ferro-alloys, Manufacture of basic chemical products, nitrogen compounds, fertilisers, plastics and synthetic rubber in primary forms and Manufacture of pulp, paper and cardboard were of particular note. Their contribution to the general index was 0.146.

Likewise, the only sector with a negative monthly contribution to the general index was:

• Capital goods, with a monthly rate of -0.1% and a contribution of -0.015, due to the drop in the prices of Manufacture of metal products for construction and Manufacture of motor vehicles.



#### Results by Autonomous Community. Interannual variation rates

The greatest increases in annual variation corresponded to the Autonomous Communities of Andalucía (8.0%), Castilla-La Mancha (5.1%) and Region de Murcia (5.7%), whose rates stood at 2.4 points above that registered in February.

In turn, the only Communities whose annual rates decreased were Comunidad Foral de Navarra, from 2.5% registered in February to 1.3% in March.
