Industrial Price Index. 2015 Base June 2023. Provisional data

The annual variation of the Industrial Price Index decreased almost one and a half points, to -8.1%

The monthly rate of industrial prices was 0.7%

Annual evolution of industrial prices

The annual rate of the general Industrial Price Index (IPRI) was -8.1% in the month of June, almost one and a half points below that registered in May.


By economic destination of the goods, all industrial sectors had a negative effect on the annual rate of the General IPRI. Among them are:

• **Energy**, which decreased by more than one and a half points, to –26.3%, due to the prices of *Refined petroleum products* increasing less than they did in June last year, and the prices of *Manufacture of gas; distribution of gaseous fuels through mains* decreasing, while they increased in the same month of 2022.

On the other hand, it is worth highlighting the increase in the prices of *Electric power generation, transmission and distribution*, compared to the decrease in June of the previous year.

- **Intermediate goods**, whose variation stands at –5.2%, more than one point below the variation of the previous month. This behaviour is due to the decrease in prices of the *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms* and, to a lesser extent, that of the *Manufacture of prepared animal feeds*, which increased in the same month last year.
- **Capital goods**, with a rate of 3.0%, six tenths below that of the previous month, due to a lower increase in the prices of *Manufacture of motor vehicles* compared to that of June 2022.

Contribution of industrial sectors to the annual IPRI rate





The annual variation rate of the general index excluding Energy decreased seven tenths, to 2.2%, standing nearly 10 and a half points above that of the general IPRI.

Monthly evolution of industrial prices

In June, the monthly variation of the overall IPRI was 0.7%.

By economic destination of goods, among the industrial sectors that presented a positive monthly impact, the following stand out:

• **Energy**, with a monthly rate of 3.3% and a contribution of 0.949, due to the increase in the prices of *Electric power generation, transmission and distribution* and, to a lesser extent, of *Refined petroleum products*.

It is worth highlighting the decrease in the prices of *Manufacture of gas; distribution of gaseous fuels through mains*.


• **Non-durable consumer goods**, with a variation of 0.2% and a contribution of 0.061, mainly due to the increase in the prices of *Manufacture of vegetable and animal oils and fats*.

In turn, the following stand out among the industrial sectors with a negative monthly impact on the index:

• **Intermediate goods**, which had a monthly rate of -0.9%, due to the decrease in prices of the *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms* and, to a lesser extent, of the *Manufacture of products for animal feed*. This sector's contribution to the overall IPRI was -0.264.

Results by Autonomous Communities. Annual variation rates


In June, the annual rate of the IPRI decreased in 13 Autonomous Communities and increased in the remaining four.

The largest decreases occurred in País Vasco, Región de Murcia and Andalucía, with decreases of 2.7 points in the former and 2.6 points in the latter two regions.

On the other hand, the communities where the rate increased the most were Canarias, Illes Balears and Principado de Asturias, with increases of 2.3, 2.0 and 1.5 points, respectively.

Data Review and Update

Coinciding with today's publication, the INE has updated the data of the IPRI series corresponding to the last three months, with the month of March 2023 becoming definitive. The results are available at INEBase.

Methodological note

The Industrial Price Index (IPRI) is a short-term indicator that measures the monthly evolution of the prices of industrial products manufactured and sold in the domestic market, in the first step of their commercialisation, that is to say, at ex-factory prices, excluding transport and commercialisation costs and invoiced VAT.

Type of survey: monthly continuous survey.

Base year: 2015.

Reference period of the weightings: the year preceding the current year.

Population scope: industrial workplaces.

Sample size: 9,000 industrial establishments and 1,500 items.

Number of observations: approximately 28,000 monthly prices.

General calculation method: Laspeyres' Chain Index.

Collection method: internet (IRIA system), e-mail, fax, telephone or postal mail.
