Industrial Price Indices. Base 2005 July 2009

The General Industrial Price Index decreases 0.2% in July as compared to the previous month

In July, the General Industrial Price Index registered a 0.2% decrease, as compared with the month of June 2009. Of the activities that registered a decrease on the previous month, those with the greatest effect were *Manufacture of coke and refined petroleum products* (-3.7%) and *Manufacture of paper and paper products* (-0.6%). Conversely, among the activities that registered an increase with respect to the previous month, that with the greatest effect was *Manufacture of food products* (0.4%) and *Manufacture of chemicals and chemical products* (0.8%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were 0.2% for Consumer goods (-0.2% for Durable consumer goods and 0.3% for Non-durable consumer goods), -0.1% for Capital goods, 0.1% for Intermediate goods and -1.0% for Energy.

The interannual rate of industrial prices decreases 6.7%

The General Industrial Price Index registered a 6.7% decrease in July 2009, as compared with the same month the previous year. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (-43.8%), *Manufacture of basic metals* (-28.7%) and *Manufacture of food products* (-5.4%).

By economic destination of the goods, the interannual variation rates were -1.2% for Consumer goods (0.7% for Durable consumer goods and -1.4% for Non-durable consumer goods), 0.5% for Capital goods, -7.8% for Intermediate goods and -16.0% for Energy.
