Industrial Price Indices. Base 2005
August 2009

The Industrial Price Index increases 0.6% in August, as compared with the previous month

The interannual rate decreases 5.5%

Monthly variation rates

In August, the Industrial Price Index registered a 0.6% increase, as compared with the month of July 2009. Of the activities that registered an increase on the previous month, those with the greatest effect were *Manufacture of coke and refined petroleum products* (8.7%) and *Manufacture of basic metals* (2.6%).

Conversely, among the activities that registered a decrease with respect to the previous month, that with the greatest effect was *Electricity, gas and water supply* (-1.4%).

Considering the classification by **economic destination of the goods**, the variation rates as compared with the previous month were 0.4% for *Consumer goods* (0.1% for *Durable consumer goods* and 0.4% for *Non-durable consumer goods*), -0.2% for *Capital goods*, 0.4% for *Intermediate goods* and 1.5% for *Energy*.

Interannual variation rates

The Industrial Price Index registered a 5.5% decrease in August 2009, as compared with the same month the previous year. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (-33.6%), *Manufacture of basic metals* (-27.4%) and *Manufacture of food products* (-5.0%).

By **economic destination of the goods**, the interannual variation rates were -0.9% for *Consumer goods* (0.8% for *Durable consumer goods* and -1.2% for *Non-durable consumer goods*), 0.3% for *Capital goods*, -7.7% for *Intermediate goods* and -11.6% for *Energy*.
