
Industrial Price Index (IPRI). Base 2010 August 2013. Provisional data

The annual rate of the Industrial Price Index stands at –0.1%, over one point below that registered in July

The monthly variation rate of the Industrial Price Index is -0.1%

Annual evolution of industrial prices

The annual rate of the Industrial Price Index (IPRI) stood at **-0.1%** in August, over one point below that registered in July.



By economic destination of the goods, the industrial sectors that most influenced the decrease in the general rate of the IPRI were:

• *Energy*, whose rate stood at **-0.8%**, over three and a half points below that registered in July. This drop was due to decrease in the prices of *Production, transportation and distribution of the electric power*, which increased in August 2012. Also, *Petroleum refinement* registered a lower increase this month, as compared with the same month of the previous year.

Within this sector, it is worth noting the increase of almost nine points in the annual rate of *Gas production*; piped distribution of gaseous products that stood at 16.0%.

- Intermediate goods, whose annual variation decreased seven tenths standing at -1.3%, its lowest rate since December 2009. This behaviour was due mainly to the decrease in the prices of Manufacture of feed products for animals as compared with the increase registered in 2012.
- **Non-durable consumer goods**, whose variation stood at **2.0%**, six tenths below that of July, due to the decrease in prices of *Manufacture of vegetable and animal oils and fats*.

In August, the monthly variation of the general IPRI was **-0.1%**.

By economic destination of the goods, the industrial sectors with the greatest negative monthly effect in the general index were:


- **Energy**, with a monthly variation of **-0.4%**, due to a decrease in the prices of *Production*, transportation and distribution of the electric power. Its effect on the general IPRI was **-0.116**. It is also worth noting the increase in the prices of *Gas production*; piped distribution of gaseous products.
- Intermediate goods, with a variation of -0.2%, and an effect of -0.067, reflecting the decrease in the prices of Manufacture of feed products for animals.

In turn, the sectors that registered a positive monthly effect in the general index were:

• **Non-durable consumer goods**, with a variation of **0.1%**, due to the increase in the prices of *Processing and preserving of meat and manufacture of meat products*. It effect on the general index was **0.022**.

• Capital goods, with a variation of 0.1% and an effect of 0.015 due to the increase in the prices of Repair of metal products, machinery and equipment and Manufacture of medical and dental instruments and supplies.


Results by Autonomous Community. Annual variation rates

The annual rate of the IPRI decreased in all the Autonomous Communities, except in La Rioja where it increased 1.5 points and stood at 5.1%.

Among the Autonomous Communities that decreased their rate, it is worth noting Canarias (-3.3%), Illes Balears (1.4%) and Andalucía (0.9%), whose annual rates decreased 5.6, 3.4 and 3.2 points, respectively.
