La tasa anual del Índice de Precios Industriales se sitúa en el –3,1%, un punto y medio por encima de la del mes de julio

La variación mensual de los precios industriales es del –0,2%

Evolución anual de los precios industriales

La tasa anual del Índice de Precios Industriales (IPRI) general en el mes de agosto es del **–3,1%**, un punto y medio por encima de la registrada en julio.


Por destino económico de los bienes, los sectores industriales que influyen en la subida de la tasa anual son:

- **Energía**, que aumenta más de cinco puntos su variación hasta el **–10,3%**, debido a que los precios del *Refino de petróleo y de la Producción, transporte y distribución de energía eléctrica* bajan este mes menos de lo que lo hicieron en agosto de 2015.
- **Bienes intermedios**, con un tasa del **–1,6%**, una décima superior al mes pasado. Destaca en esta evolución el descenso de los precios de la *Producción de metales preciosos y de otros metales no férreos*, inferior al del año pasado.

Por su parte, el sector industrial con mayor influencia negativa es:


- **Bienes de consumo no duradero**, cuya variación se sitúa en el **–0,4%**, cuatro décimas por debajo de la de julio, a consecuencia de la bajada de los precios de la *Fabricación de aceites y grasas vegetales y animales*, frente a la subida registrada en 2015.

La tasa de variación anual del **índice general sin Energía** baja una décima hasta el **-0,6%**, con lo que disminuye su diferencia con la del IPRI general, situándose dos puntos y medio por encima de ella.

En agosto la tasa de variación mensual del IPRI general es del **-0,2%**.


Por destino económico de los bienes, entre los sectores industriales que tienen repercusión mensual negativa en el índice general destacan:

- **Energía**, con una tasa del **-0,4%** y una repercusión de **-0,108**, debidas a la bajada de los precios de la *Producción, transporte y distribución de energía eléctrica* y, en menor medida, del *Refino de petróleo*.

Cabe reseñar también, aunque en sentido contrario, la subida de los precios de la *Producción de gas; distribución por tubería de combustibles gaseosos*.

- **Bienes intermedios**, cuya variación mensual del **-0,3%** repercute **-0,100** en el IPRI general. Destaca en este comportamiento el descenso de los precios de la *Fabricación de productos básicos de hierro, acero y ferroaleaciones* y la *Fabricación de productos químicos básicos, compuestos nitrogenados, fertilizantes, plásticos y caucho sintético en formas*.


Resultados por comunidades autónomas. Tasas de variación anual

La tasa anual del IPRI aumenta en todas las comunidades autónomas. Los mayores incrementos se registran en Canarias (-7,0%), Illes Balears (-8,5%) y Castilla - La Mancha (-5,2%), cuyas tasas aumentan 5,8, 3,5 y 2,1 puntos, respectivamente.

Por su parte, Extremadura refleja la menor subida, de una décima, lo que sitúa su tasa anual en el -1,3%.
