

Industrial Price Indices. Base 2000
October 2008

The General Industrial Price Index decreases 1.2% in October as compared with the previous month

In October, the General Industrial Price Index registered a 1.2% decrease as compared with the month of September 2008. The activities that most influenced this variation were *Manufacture of coke oven products and refinement of petroleum* (-11.2%), *Metallurgy* (-6.5%) and *Food and beverage products industry* (-1.1%). In contrast, among the activities that recorded an increase as compared with the previous month, the activity with the greatest repercussion was *Production and distribution of electricity and gas* (4.4%).

Considering the classification by economic destination of the goods, the intermonthly variation rates were -0.4% for consumer goods (0.1% for durable consumer goods and -0.5% for non-durable consumer goods), 0.1% for capital goods, -1.5% for intermediate goods and -2.9% for energy.

The interannual rate of the General Index increases 5.9%

The General Industrial Price Index registered an increase of 5.9% in October 2008, as compared with the same month from the previous year. The activities that most influenced this variation were *Production and distribution of electricity and gas* (17.2%) and *Manufacture of coke oven products and refinement of petroleum* (13.0%).

By economic destination of the goods, the interannual variation rates were 2.9% for consumer goods (3.3% for durable consumer goods and 2.8% for non-durable consumer goods), 2.1% for capital goods, 5.0% for intermediate goods and 15.2% for energy.
