Industrial Price Index (IPRI). Base 2005
October 2010. *Provisional data*

Main results

- The **interannual** variation rate of the IPRI for the month of October stands at **4.1%**, seven tenths higher than that registered in September.
- The **monthly** variation of the general index is **0.6%**.
- All of the **Autonomous Communities** register positive **interannual** rates.
- **Andalucía** and **Región de Murcia** are the Autonomous Communities that present the highest interannual variation rate.

Annual evolution of industrial prices

The interannual rate for the Industrial Price Index (IPRI) increased seven tenths in October, standing at **4.1%**.

By economic destination of the goods, the industrial sectors that most influenced this increase were:

• **Energy**, whose annual variation stood at **10.4%**, more than one point higher than that registered in September. This increase was mainly due to the increase in prices of the *Production, transport and distribution of electrical energy*, as compared with the decrease experienced in October the previous year. In fact, the annual rate of this activity increased more than four points, standing at 5.3%.


Despite the increase recorded in the annual variation of *Energy*, worth nothing was the drop in price of *Refined petroleum products*, whose rate decreased four points, standing at 20.4%.

• **Non-durable consumer goods**, whose annual variation increased five tenths, standing at **0.5%**. The most noteworthy divisions, due to their contribution to this variation, were the *Processing and preserving of meat and production of meat products* and the *Manufacture of vegetable and animal oils and fats*.

• **Intermediate goods**, with an annual rate of **4.4%**, four tenths higher than that registered in September, due to the rise in prices of the *Manufacture of animal feed products*, the *Manufacture of grain mill products, starches and starch products* and the *Manufacture of basic chemical products, nitrogen compounds, fertilisers, plastics and synthetic rubber in primary forms*, as compared with the drops registered in October 2009.

Also worth noting was the drop in prices of the *Manufacture of basic iron, steel and ferro-alloy products*, whose annual rate dropped more than four points, standing at 9.8%.

Annual rates of the IPRI General index and by economic destination




Monthly evolution of industrial prices

In October, the monthly variation of the IPRI was **0.6%**.

By economic destination of the goods, all of the industrial sectors presented a positive effect on the general index. Those that most influenced this rise were:

- **Energy**, whose monthly rate of **1.8%** contributed **0.415** to the general index, mostly caused by the increase in price of the *Production, transport and distribution of electrical energy*.
- **Intermediate goods**, with a monthly rate of **0.3%**, and an effect of **0.086**. Worth noting in this variation was the rise in the prices of the *Manufacture of animal feed products*, the *Manufacture of grain mill products, starches and starch products* and the *Manufacture of basic chemical products, nitrogen compounds, fertilisers, plastics and synthetic rubber in primary forms*.
- **Non-durable consumer goods**, with a monthly rate of **0.2%**. This behaviour reflected the increase in price of the *Manufacture of vegetable and animal oils and fats*. Its contribution to the general index was **0.043**.



Results by Autonomous Community. Interannual variation rates

The greatest increases in annual variation corresponded to the Autonomous Communities of Illes Balears (2.7 points), Castilla y León (1.2 points) and Canarias (1.1 puntos), whose rates stood at 3.6%, 2.3% and 5.9%, respectively.

In turn, the only Autonomous Community whose annual rate decreased was País Vasco, from 6.3% registered in September to 5.9% in October.
