**The General Index of Industrial Prices decreases 2.6% in November
as compared to the previous month**

In November, the General Index of Industrial Prices registered a 2.6% decrease as compared with the month of October 2008. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (-19.4%), *Metallurgy* (-7.4%) and *Food and beverage products industry* (-1.1%). In contrast, among the activities that recorded an increase as compared with the previous month, the activity with the greatest repercussion was *Extraction of energy* (3.4%).

Considering classification by economic destination of the goods, the intermonthly variation rates were -0.4% for consumer goods (0.1% for durable consumer goods and -0.5% for non-durable consumer goods), -2.0% for intermediate goods and -8.3% for energy. Capital goods experienced no variation.

The interannual rate of Industrial prices increases 2.5%

The General Index of Industrial Prices registered an increase of 2.5% in November 2008, as compared with the same month the previous year. The activities that most influenced this variation were *Production and distribution of electricity and gas* (16.7%) and the *Chemical industry* (5.1%).

By economic destination of the goods, the variation rates were 2.1% for consumer goods (3.3% for durable consumer goods and 1.9% for non-durable consumer goods), 2.0% for capital goods, 2.9% for intermediate goods and 2.9% for energy.
