#### Industrial Price Indices. Base 2005 November 2009

The interannual rate of the Industrial Price Index for the month of November increases more than two points, standing at -1.8%

### The monthly variation of the general index is 0.0%

#### Interannual variation rates

The Industrial Price Index registered a 1.8% decrease in November 2009, as compared with the same month the previous year, two-and-a-half points greater than in October. The activities that most influenced this variation were *Manufacture of basic metals* and *Manufacture of food products*, whose annual rates stood at –13.1% and –3.6%.

By **economic destination of the goods**, the interannual variation rates were -0.7% for Consumer goods (0.1% for Durable consumer goods and -0.7% for Non-durable consumer goods), 0.2% for Capital goods, -4.6% for Intermediate goods and -0.7% for Energy.

#### Monthly variation rates

The monthly variation rate of the Industrial Price Index in November 2009 was 0.0%. Of the activities that registered a decrease over the previous month, those with the greatest effect were *Manufacture of food products* and *Manufacture of chemicals and chemical products*, with rates of -0.6% and -0.9%, respectively. Conversely, among the activities that registered an increase as compared with the previous month, that with the greatest effect was *Manufacture of coke and refined petroleum products* (3.1%).

Considering the classification by **economic destination of the goods**, the variation rates as compared with the previous month were -0.4% for *Consumer goods* (0.1% for *Durable consumer goods* and -0.4% for *Non-durable consumer goods*), -0.0% for *Capital goods*, -0.4% for *Intermediate goods* and 0.8% for *Energy*.
