Industrial Price Index (IPRI). Base 2005
November 2010. *Provisional data*

Main results

- The **interannual** variation rate of the IPRI for the month of November stands at **4.4%**, three tenths higher than that registered in October.
- The **monthly** variation of the general index is **0.3%**.
- All **Autonomous Communities** register **positive** interannual rates.
- **Andalucía** is the Autonomous Community that presents the highest interannual variation rate, with **7.7%**.

Annual evolution of industrial prices

The interannual rate for the Industrial Price Index (IPRI) increased three tenths in November, standing at **4.4%**.

By economic destination of the goods, the industrial sectors that most influenced this increase were:

• **Intermediate goods**, whose annual variation stood at **5.1%**, eight tenths higher than that registered in October. The most noteworthy divisions, due to their contribution to this variation were the *Manufacture of basic chemical products, nitrogen compounds, fertilisers, plastics and synthetic rubber in primary forms*, the *Manufacture of animal feed products* and the *Manufacture of grain mill products, starches and starch products*, whose prices increased in November 2010 as compared with the decrease registered in 2009.

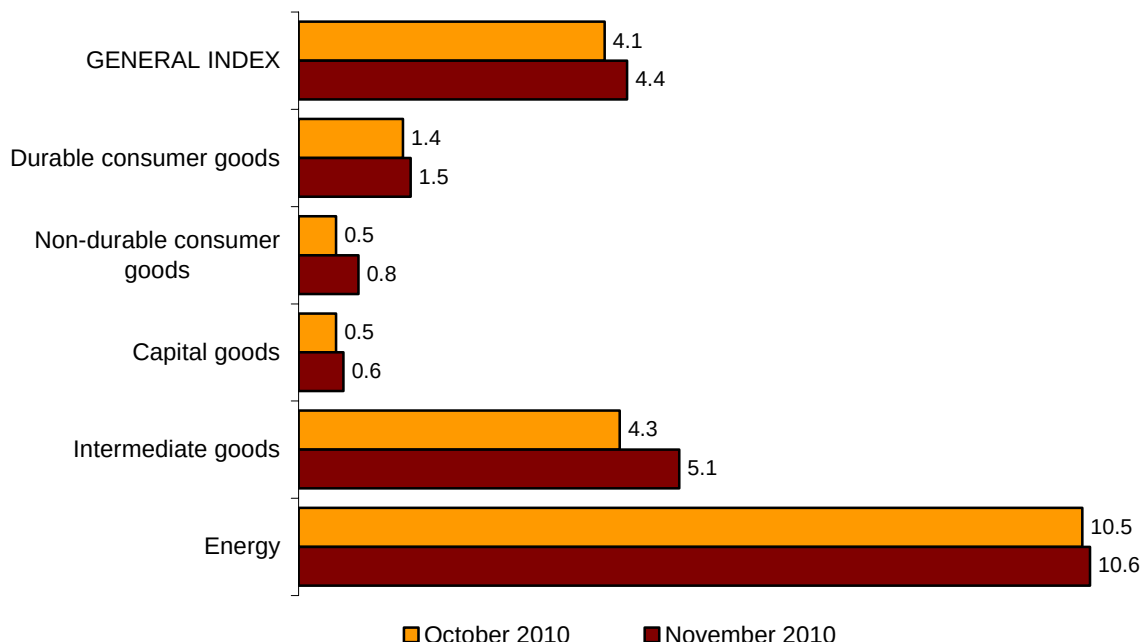
• **Non-durable consumer goods**, whose annual variation increased three tenths, standing at **0.8%**. This increase was mainly due to the increase in prices of the *Manufacture of vegetable and animal oils and fats*, whose rate increased six points, standing at 2.3%

• **Energy**, with an annual rate of **10.6%**, one tenth higher than that registered in October, mainly due to the rise in prices of the *Refined petroleum products*.

Despite the increase recorded in the annual variation of *Energy*, worth nothing was the drop in price of *Production, transport and distribution of Electrical Energy*, whose annual rate decreased three tenths, standing at 5.0%.

Monthly evolution of industrial prices

In November, the monthly variation of the IPRI was **0.3%**.

By economic destination of the goods, the industrial sectors that presented a positive effect on the general index were:

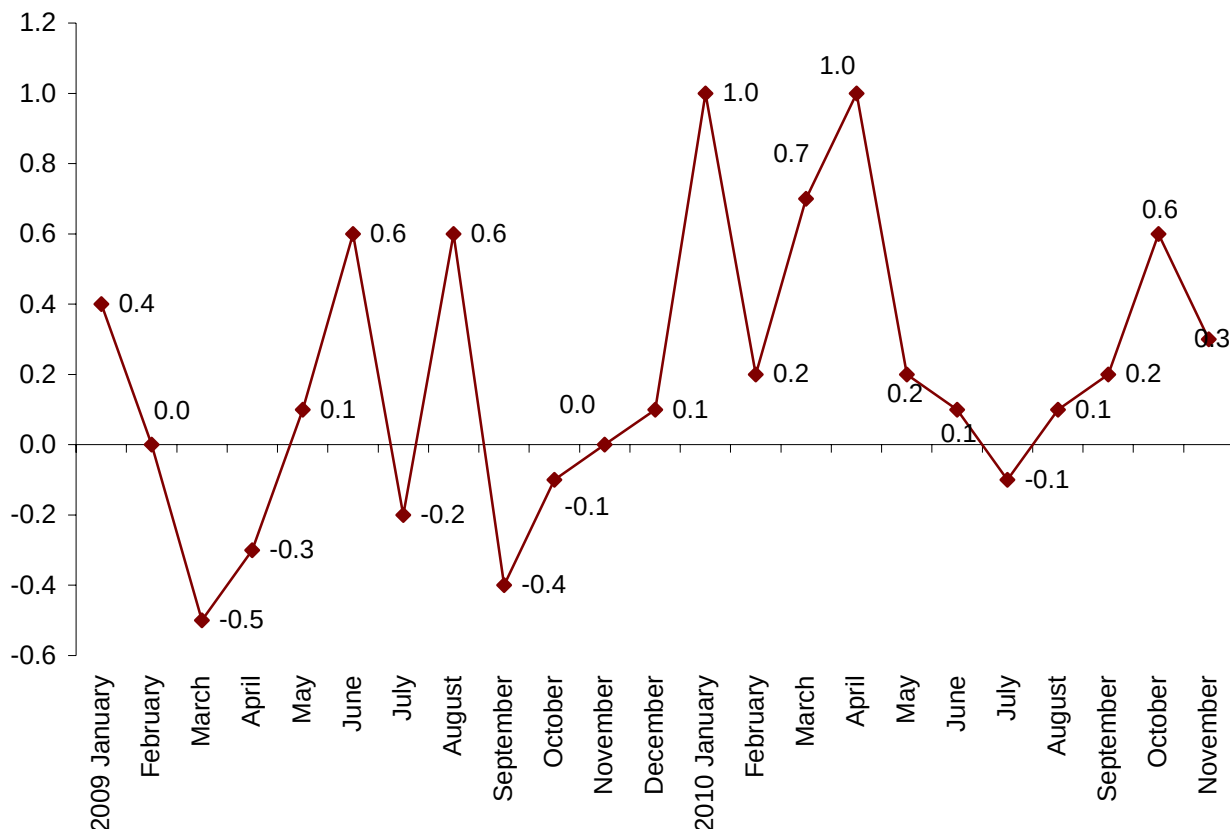
- **Energy**, whose monthly rate of **0.9%** contributed **0.215** to the general index, mostly caused by the increase in price of the *Refined petroleum products*.

- **Intermediate goods**, with a monthly rate of **0.4%**, and an effect of **0.142**. Worth noting in this variation was the rise in the prices of the *Production of precious metals and other non-ferrous metals*, the *Manufacture of basic chemical products, nitrogen compounds, fertilisers, plastics and synthetic rubber in primary forms* and the *Manufacture of animal feed products*.

In turn, the only sector with a negative monthly contribution in the general index was:

- **Non-durable consumer goods**, with a monthly rate of **-0.1%**. This behaviour reflected the decrease in price of the *Processing and preserving of meat and production of meat products*. Its contribution to the general index was **-0.021**.

A more detailed analysis showed the activities that most affected the monthly rate of the IPRI in the month of November.

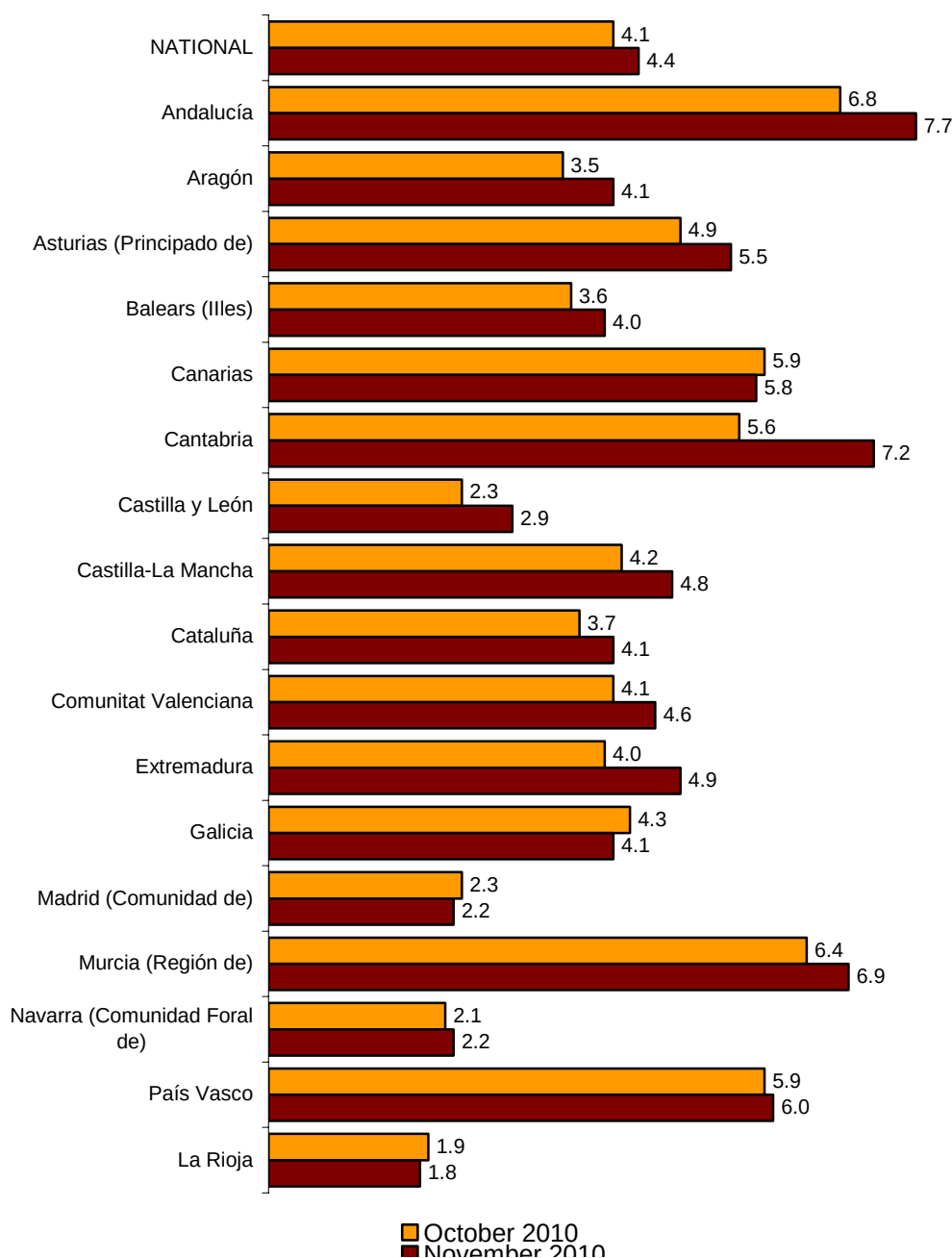
Results by Autonomous Community. Interannual variation rates

The greatest increases in annual variation corresponded to the Autonomous Communities of Cantabria (1.6 points), Extremadura (0.9 points) and Andalucía (0.9 points), whose rates stood at 7.2%, 4.9% and 7.7%, respectively.

In turn, the Autonomous Community whose annual rate decreased the most was Galicia, from 4.3% registered in October to 4.1% in November.
