

Industrial Price Indices. Base 2000
December 2007

The General Industrial Price Index increases 0.5% in December as compared to the previous month

In December, the General Industrial Price Index registered a 0.5% increase with respect to the month of November 2007. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (3.7%) and *Food and beverage products industry* (0.8%). In contrast, among the activities that recorded a decrease with respect to the previous month, the activity with the greatest repercussion was *Metallurgy* (-1.5%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were 0.5% for consumer goods (0.1% for durable consumer goods and 0.5% for non-durable consumer goods), -0.1% for intermediate goods and 1.7% for energy. Capital goods did not experience any variation.

The interannual rate of the General Index increases 5.9%

The General Industrial Price Index registered an increase of 5.9% in December 2007 with respect to the previous year. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (21.1%) and *Food and beverage products industry* (9.5%).

By economic destination of the goods, the variation rates as compared with the previous year were 4.9% for consumer goods (3.1% for durable consumer goods and 5.1% for non-durable consumer goods), 2.9% for capital goods, 4.9% for intermediate goods and 11.6% for energy.
