Industrial Price Indices. Base 2000 December 2008

The General Industrial Price Index decreases 2.2% in December as compared to the previous month

In December, the General Industrial Price Index registered a 2.2% decrease as compared with the month of November 2008. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (-21.6%), *Metallurgy* (-4.5%) and *Chemical industry* (-2.6%). In contrast, among the activities that recorded an increase as compared with the previous month, the activity with the greatest repercussion was *Extraction of energy products* (0.9%).

Considering classification by economic destination of the goods, the intermonthly variation rates were -0.2% for Consumer goods (-0.1% for Durable consumer goods and -0.2% for Non-durable consumer goods), -1.7% for Intermediate goods and -8.1% for Energy. Capital goods experienced no variation.

The interannual rate of Industrial prices decreases 0.2%

The General Industrial Price Index registered a decrease of 0.2% in December 2008, as compared with the same month the previous year. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (-35.2%) and *Metallurgy* (-1.8%).

By economic destination of the goods, the interannual variation rates were 1.6% for Consumer goods (3.0% for Durable consumer goods and 1.4% for Non-durable consumer goods), 2.0% for Capital goods, 1.1% for Intermediate goods and -7.0% for Energy.
