Industrial Price Indices. Base 2005
December 2009

The interannual rate of the Industrial Price Index for the month of December increases more than two points, standing at 0.4%

The monthly variation of the general index is 0.1%

Interannual variation rates

The Industrial Price Index registered a 0.4% increase in December 2009, as compared with the same month the previous year, thereby standing at positive levels for the first time since December 2008. The activity that most influenced this variation was *Manufacture of coke and refined petroleum products* (21.7%).

By **economic destination of the goods**, the interannual variation rates were -0.5% for *Consumer goods* (-0.6% for *Durable consumer goods*; *Non-durable consumer goods* did not experience any variation), 0.1% for *Capital goods*, -2.7% for *Intermediate goods* and 6.3% for *Energy*.

Monthly variation rates

The monthly variation rate of the Industrial Price Index in December 2009 was 0.1%.

The activities with the greatest positive effect on the index were *Electricity, gas and water supply* (0.5%) and *Manufacture of electrical equipment* (0.3%).

Likewise, among the activities that registered a decrease as compared with the previous month, those with the greatest effect were *Manufacture of coke and refined petroleum products* (-0.7%) and *Manufacture of rubber and plastic products* (-0.4%).

Considering the classification by **economic destination of the goods**, the variation rates as compared with the previous month were -0.1% for *Consumer goods* (-0.1% for *Durable consumer goods* and -0.1% for *Non-durable consumer goods*), -0.1% for *Capital goods*, 0.1% for *Intermediate goods* and 0.2% for *Energy*.
