Mercantile Companies Statistics

January 2011. Provisional data

The number of mercantile companies created in January increases 13.6% as compared with the same month of 2010

The number of mercantile companies dissolved increases 13.1% in the interannual rate

7,123 mercantile companies were created in January, 13.6% more than in the same month of 2010, and 15.0% more than in December 2010. The capital subscribed for their constitution exceeded 459 million euros, 8.5% less than in January the previous year. The average capital subscribed (64,519 euros) registered an interannual decrease of 19.5%.

On the other hand, 3,585 mercantile companies increased their capital in January, 17.0% less than in the same month of 2010. The capital subscribed in the increases registered an interannual increase of 75.4%, and exceeded 8,293 million euros. The average capital subscribed in these transactions (2,313,268 euros) recorded an interannual increase of 111.3%.

The number of companies dissolved in January was 2,841, indicating an interannual increase of 13.1%. Of these, 77.2% did so voluntarily, 14.3% due to mergers and the remaining 8.5% for other reasons.


Results by type of company

Out of the 7,123 mercantile companies created in the month of January, 99.1% were private limited companies and 0.9% were public limited companies. Out of the 3,585 companies that increased their capital, 90.8% were private limited companies and 9.2% were public limited companies.

70.9% of the capital registered by the mercantile companies created was subscribed by private limited companies, and 29.1% by public limited companies. Regarding the capital subscribed in capital increases, 35.1% corresponded to private limited companies, and 64.9% to public limited companies.

The interannual rate of the number of public limited companies decreased 10.1% in January, and the corresponding rate of private limited companies increased 13.9%. Considering the companies that increased their capital, the number of public limited companies registered an interannual decrease of 23.1%, and that of private limited companies decreased 16.3%.

The capital subscribed by the public limited companies created decreased 9.6%, while the capital subscribed by private limited companies decreased 8.0%, in interannual terms. As per the capital subscribed by the companies increasing their capital, the interannual rate for public limited companies increased 171.0%, and for private limited companies 6.1%

Results by Autonomous City and Community

Illes Balears presented the greatest average capital subscribed by the mercantile companies created in January, with 248,749 euros. Conversely, Canarias registered the least average capital subscribed (20,181 euros).

País Vasco recorded the greatest average capital subscribed by companies increasing their capital (6,657,057 euros), while Extremadura recorded the least average capital subscribed (258,627 euros).

Out of the total capital subscribed in the creation of mercantile companies during the month of January, Comunidad de Madrid accounted for the highest percentage (34.0%), while La Rioja recorded the lowest percentage (0.3%).

Regarding the total capital subscribed by the mercantile companies increasing their capital, Comunidad de Madrid registered the highest percentage (51.9%), while Cantabria recorded the lowest (0.0%).
