Mercantile Companies Statistics (MC)

January 2020. Provisional data

During the month of January, 8,656 mercantile companies were created, 3.8% fewer than in the same month of 2019.

Principado de Asturias (30.8%) registered the highest annual increases in the number of mercantile companies created

During the month of January, 8,656 mercantile companies were created, 3.8% fewer than in the same month of 2019. The share capital for their constitution exceeded 868 million Euros, with an annual increase of 43.8%. The average subscribed capital (100,285 euros) increased by 49.4%.

On the other hand, 3,549 mercantile companies increased their capital in January, 5.5% less than in the same month of 2019. The capital subscribed in the increases recorded a 20.6% decrease and exceeded 3,026 million euros. The average capital subscribed in these transactions (852,816 euros) decreased by 16.1% in the annual rate.

The number of mercantile companies dissolved in January was 3,553, 14.5% less than in the same month of 2019. Of these, 82.6% did so voluntarily, 11.0% due to mergers and the remaining 6.4% for other reasons.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between December and January in the last five years. In 2020, the monthly variation in the number of companies created was 22.0% and 31.0% in the number of companies dissolved.

Results by main economic activity

Of the mercantile companies created in January, 18.6% corresponded to *Trade* and 15.3% to *Real estate, financial and insurance companies*. Regarding dissolved companies, 19.3% corresponded to Trade and 16.6% to *Construction*.

Mercantile companies created by main economic activity




Mercantile companies dissolved by main economic activity



The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 657.61 million euros. In turn, *Administrative and support service activities* registered the lowest capital, with 5.75 million.


Subscribed capital of mercantile companies created by main economic activity January 2020. Thousands of euros



In relation to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 496,547 euros per company. *Administrative activities and auxiliary services* were the lowest, with 14,748 euros.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in January were Comunidad de Madrid (1,907), Cataluña (1,768), and Andalucía (1,501). In turn, those with the lowest number of mercantile companies created were La Rioja (37), Cantabria (49) and Comunidad Foral de Navarra (68).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (1,110), Andalucía (477) and Comunitat Valenciana (290). In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (seven), La Rioja (24) and Región de Murcia (39).




Principado de Asturias (30,8%), Canarias (12,1%) y Aragón (5,8%) show the highest annual rates in the number of mercantile companies created. In turn, Cantabria (-42.4%), Comunidad Foral de Navarra (-19.0%) and Castilla y León (-15.3%) registered the greatest decreases.

In regards to dissolved mercantile companies, the highest rates were recorded in Cantabria (23,1%), Castilla y León (16,0%) and Principado de Asturias (11,8%). On the other hand, Castilla – La Mancha (–90,6%)¹, Comunidad Foral de Navarra (–41,7%) and Región de Murcia (–13,3%) showed the greatest decreases.

Revision and updating of data

Data for 2020 are provisional and will be reviewed when the data for the same period of the next year are published. That is, when the data for January 2021 are published, the final data for the same month in 2020 will be disseminated.

Methodological note

The Mercantile Companies Statistics (MCS) was created by Order of 30 September 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces.

Reference period of the results: the calendar month.

Reference period of the information: the calendar month.

Collection method: administrative records.
