Mercantile Companies Statistics February 2009. Provisional data

The number of mercantile companies created in February decreases 36.1% as compared with the same month of 2008

The number of mercantile companies dissolved decreases 1.3% in the interannual rate

During the month of February, 7,582 mercantile companies were created, 36.1% less than in the same month of 2008, 17.0% more than that registered in January 2009. The capital subscribed for their constitution was more than 686 million euros, 41.7% less than in February of the previous year. In turn, the average capital subscribed (90,560 euros) registered an interannual decrease of 8.9%.

On the other hand, in February, 4,190 mercantile companies increased their capital, 17.1% less than for the same month of 2008. The capital subscribed in the increases registered an interannual decrease of 11.8%, and exceeded 3,642 million euros. The average capital subscribed in these transactions (869,281 euros) increased 6.4%.

The number of companies dissolved in February was 1,895, indicating an interannual decrease of 1.3%. Of these, 87.2% did so voluntarily, 8.2% due to mergers and the remaining 4.6% for other reasons.


Private limited companies account for 98.9% of the companies created, and 90.0% of those increasing their capital

Out of the 7,582 mercantile companies created in the month of February, 98.9% were private limited companies and 1.1% were public limited companies. Out of the 4,190 companies that increased their capital, 90.0% were private limited companies and 10.0% were public limited companies.

81.5% of the capital registered by the mercantile companies created was subscribed by private limited companies, and 18.5% by public limited companies. Regarding the capital subscribed in capital increases, 58.0% corresponded to private limited companies, and 41.7% to public limited companies.



The interannual rate of the number of public limited companies created decreased 46.8% in February, and the corresponding rate of private limited companies decreased 35.9%. Considering the companies that increased their capital, the number of public limited companies decreased 6.1%, and that of private limited companies, 18.2%.

The capital subscribed by the public limited companies created decreased 51.9% in the interannual rate, and the capital subscribed by private limited companies decreased 38.8%. As per the capital subscribed by companies increasing their capital, the interannual rate for public limited companies increased 15.9%, while that for private limited companies decreased 25.0%.

País Vasco registers the greatest average capital in companies created and Comunidad de Madrid in companies increasing their capital

By Autonomous Community, País Vasco presented the greatest average capital subscribed by the mercantile companies created in February (431,458 euros). In contrast, Cantabria registered the least average capital subscribed (18,557 euros). Comunidad de Madrid recorded the greatest average capital subscribed by companies increasing capital (1,535,652 euros), and Principado de Asturias recorded the least average capital subscribed (319,672 euros).

Cataluña accounts for 31.2% of the total capital subscribed by the companies created

Out of the total capital subscribed in the creation of mercantile companies during the month of February, Cataluña accounted for the highest percentage (31.2%), while La Rioja accounted for the lowest percentage (0.1%).

Regarding the total capital subscribed by the mercantile companies increasing their capital, Comunidad De Madrid registered the highest percentage (31.5%), while La Rioja recorded the lowest (0.2%).
