Mercantile Companies Statistics (MC) February 2020. Provisional data

In February, 8,516 mercantile companies were created, 9.2% less than in the same month of 2019.

La Rioja (7.7%) registered the highest annual increases in the number of mercantile companies created

In February, 8,516 mercantile companies were created, 9.2% less than in the same month of 2019. The subscribed capital for their constitution exceeded 422 million euros, with an annual decrease of 50.2%. The average subscribed capital (49,599 euros) decreased by 45.1%.

On the other hand, 3,048 mercantile companies increased their capital in February, 4.5% less than in the same month of 2019. The capital subscribed in the increases grew 7.0% and exceeded 2,405 million euros. The average capital subscribed in these transactions (789,265 euros) increased 12.1% in annual rate.

The number of mercantile companies dissolved in February was 2,416, indicating 4.5% more than in the same month of 2019. Of these, 76.5% did so voluntarily, 14.0% due to mergers and the remaining 9.5% for other reasons.


Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between January and February in the last five years. In 2020, the monthly variation in the number of companies created was -1.6%, and -32.0% in the number of companies dissolved.


Performance of the monthly rate of mercantile companies created and dissolved February variation is compared with January of the same year. Percentage



Results by main economic activity


Of the mercantile companies created in February, 19.4% corresponded to *Trade* and 15.9% to *Real estate, financial and insurance companies.* Regarding dissolved companies, 20.3% corresponded to *Trade* and 16.9% to *Construction*.

Mercantile companies dissolved by main economic activity February 2020. Percentage



The economic activity with the greatest subscribed capital of mercantile companies created was *Real estate, financial and insurance activities*, with 281.53 million euros. In turn, *Administrative and support service activities* registered the lowest capital, with 3.23 million.


Capital subscribed of mercantile companies created by main economic activity February 2020. Thousands of euros



In relation to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 207,914 euros per company. *Administrative activities and auxiliary services* were the lowest, with 8,233 euros.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in February were Comunidad de Madrid (1,971), Cataluña (1,710), and Andalucía (1,277). In turn, those with the lowest number of mercantile companies created were La Rioja (42), Cantabria (56) and Comunidad Foral de Navarra (67).

Regarding dissolved mercantile companies, the ones that registered the highest number were Comunidad de Madrid (851), Andalucía (394) and Cataluña (184). In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (eight), Región de Murcia (11) and La Rioja (22).




La Rioja (7.7%), Cataluña (3.6%) and Cantabria (1.8%) had the highest annual rates in the number of mercantile companies created. On the other hand, Región de Murcia (–29.8%), Principado de Asturias (–24.6%) y Comunidad Foral de Navarra (–23.0%) showed the largest decreases.

In regards to dissolved merchantile companies, the highest rates were recorded in Cataluña (27.8%), Comunidad de Madrid (23.3%) and Cantabria (20.8%). Conversely, Región de Murcia (–73.2%), Extremadura (–39.6%) and Principado de Asturias (–34,8%) showed the greatest decreases.

Revision and updating of data

Data for 2020 are provisional and will be reviewed when the data for the same period of the next year are published. In other words, when the data for February 2021 are published, the final data for the same month in 2020 will be disseminated.

Methodological note

The Mercantile Companies Statistics (MCS) was created by Order of 30 September 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces.

Reference period of the results: the calendar month.

Reference period of the information: the calendar month.

Collection method: administrative records.
