# The number of mercantile companies created in March decreases 12.2% as compared with the same month of 2008

# The number of mercantile companies dissolved increases 45.7% in the interannual rate

During the month of March, 8,404 mercantile companies were created, 12.2% less than in the same month of 2008, 10.8% more than that registered in February 2009. The capital subscribed for their constitution was more than 388 million euros, 26.8% less than in March of the previous year. In turn, the average capital subscribed (46,180 euros) registered an interannual decrease of 16.6%.

On the other hand, in March, 3,747 mercantile companies increased their capital, 10.5% more than for the same month of 2008. The capital subscribed in the increases registered an interannual decrease of 13.4%, and exceeded 5,378 million euros. The average capital subscribed in these transactions (1,435,374 euros) decreased 21.6%.


The number of companies dissolved in March was 1, 475, indicating an interannual increase of 45.7%. Of these, 86.8% did so voluntarily, 7.0% due to mergers and the remaining 6.2% for other reasons.

## Private limited companies account for 99.1% of the companies created, and 90.8% of those increasing their capital

Out of the 8,404 mercantile companies created in the month of March, 99.1% were private limited companies and 0.8% were public limited companies. Out of the 3,747 companies that increased their capital, 90.8% were private limited companies and 9.1% were public limited companies.

74.1% of the capital registered by the mercantile companies created was subscribed by private limited companies, and 25.9% by public limited companies. Regarding the capital subscribed in capital increases, 36.6% corresponded to private limited companies, and 63.4% to public limited companies.



The interannual rate of the number of public limited companies created decreased 28.1% in March, and the corresponding rate of private limited companies decreased 12.1%. Considering the companies that increased their capital, the number of public limited companies increased 4.0%, and that of private limited companies, 11.2%.

The capital subscribed by the public limited companies created decreased 57.3% in the interannual rate, and the capital subscribed by private limited companies decreased 2.3%. As per the capital subscribed by companies increasing their capital, the interannual rate for public limited companies increased 25.6%, while that for private limited companies decreased 43.6%.

## Región de Murcia registers the greatest average capital in companies created and Comunidad de Madrid in companies increasing their capital

By Autonomous Community, Región de Murcia presented the greatest average capital subscribed by the mercantile companies created in March (201,768 euros). In contrast, Extremadura registered the least average capital subscribed (14,425 euros). Comunidad de Madrid recorded the greatest average capital subscribed by companies increasing capital (2,867,832 euros), and Cantabria recorded the least average capital subscribed (149,769 euros).

## Cataluña accounts for 20.5% of the total capital subscribed by the companies created

Out of the total capital subscribed in the creation of mercantile companies during the month of March, Cataluña accounted for the highest percentage (20.5%), while La Rioja accounted for the lowest percentage (0.2%).

Regarding the total capital subscribed by the mercantile companies increasing their capital, Comunidad De Madrid registered the highest percentage (38.2%), while Cantabria recorded the lowest (0.1%).
