Mercantile Companies Statistics March 2010. Provisional data

The number of mercantile companies created in March increases 3.8% as compared with the same month of 2009

The number of mercantile companies dissolved increases 2.7% in the interannual rate

8,721 mercantile companies were created in March, 3.8% more than the same month of 2009 and 12.5% more than in February 2010. The capital subscribed for their constitution exceeded 306 million euros, 21.1% less than in March the previous year. The average capital subscribed (35,135 euros) registered an interannual decrease of 23.9%.

On the other hand, in March, a total of 3,482 mercantile companies increased their capital, 7.1% less than in the same month of 2009. The capital subscribed in the increases registered an interannual decrease of 39.4%, and reached almost 3,262 million euros. The average capital subscribed in these transactions (936,777 euros) recorded an interannual decrease of 34.7%.

The number of companies dissolved in March was 1,589, indicating an interannual increase of 2.7%. Of these, 78.1% did so voluntarily, 7.4% due to mergers and the remaining 14.5% for other reasons.



Out of the 8,721 mercantile companies created in the month of March, 99.1% were private limited companies and 0.9% were public limited companies. Out of the 3,482 companies that increased their capital, 90.8% were private limited companies and 9.2% were public limited companies.

81.3% of the capital registered by the mercantile companies created was subscribed by private limited companies, and 18.7% by public limited companies. Regarding the capital subscribed in capital increases, 56.9% corresponded to private limited companies, and 43.1% to public limited companies.



The interannual rate of the number of public limited companies created increased 13.0% in March, and the corresponding rate of private limited companies increased 3.7%. Considering the companies that increased their capital, the number of public limited companies decreased 6.5%, and that of private limited companies, 7.1%.

The capital subscribed by the public limited companies created decreased 43.0% and the capital subscribed by private limited companies 13.4%, in interannual terms. As per the capital subscribed by the companies increasing their capital, the interannual rate for public limited companies decreased 58.8%, and that for private limited companies decreased 5.7%.

Comunidad de Madrid presented the greatest average capital subscribed by the mercantile companies created (56,971 euros) in March. Conversely, Cantabria registered the least average capital subscribed (10,135 euros).

Aragón recorded the greatest average capital subscribed by companies increasing their capital (2,068,598 euros), while Extremadura recorded the least average capital subscribed (124,596 euros).

Out of the total capital subscribed in the creation of mercantile companies during the month of March, Comunidad de Madrid accounted for the highest percentage (33.0%), while La Rioja accounted for the lowest percentage (0.2%).

Regarding the total capital subscribed by the mercantile companies increasing their capital, Cataluña registered the highest percentage (35.6%), while Cantabria recorded the lowest (0.1%).
