### Mercantile Companies Statistics (MC) March 2023. Provisional data

# In March, 12,076 mercantile companies were created, 8.9% more than in the same month of 2022.

# The number of companies dissolved was 2,336, with an annual decrease of 8.8%

In March, 12,076 mercantile companies were created, 8.9% more than in the same month of 2022. The subscribed capital for their constitution exceeded 525 million euros, with an annual increase of 34.2%. The average subscribed capital (43,548 euros) increased by 23.2%.

On the other hand, in March, a total of 2,991 mercantile companies increased their capital, 4.4% more than in the same month of 2022. The capital subscribed in the increases registered a decrease of 16.3% and reached 1,856 million euros. The average subscribed capital in these transactions (620,462 euros) declined by 19.8% in the annual rate.

The number of mercantile companies dissolved in March was 2,336, which is 8.8% less than in the same month of 2022. Of these, 85.0% did so voluntarily, 8.5% due to mergers and the remaining 6.5% for other reasons.

#### Evolution of the monthly rate



In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between February and March in the last five years. In 2023, the monthly variation in the number of companies created was 18.9%, and -13.6% in the number of companies dissolved.

November variation is compared with October of the same year. Percentage




#### Results by main economic activity

Of the mercantile companies created in March, 18.9% corresponded to *Trade* and 16.5% to *Real estate, financial and insurance companies.* Regarding the dissolved companies, 18.2% corresponded to *Trade* and 16.6% to *Real Estate, finance and insurance* and another 16.6% to *Construction.*

March 2023. Percentage



March 2023. Percentage



The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 321.81 million euros. In turn, *Information and communications* presented the lowest subscribed capital, with 4.22 million.

# Capital subscribed of mercantile companies created by main economic activity


March 2023. Thousands of euros



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 161,505 euros per company. In turn, *Information and communications* registered the lowest average, with 8,518 euros.

#### **Results by Autonomous Community**

The Autonomous Community with the greatest number of mercantile companies created in March were Comunidad de Madrid (2,806), Andalucía (2,208), and Cataluña (2,107).

In turn, those with the lowest number of mercantile companies created were La Rioja (50), Cantabria (79) and Comunidad Foral de Navarra (86).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (812), Andalucía (426) and Comunitat Valenciana (166).


In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (dos), La Rioja (16) and Castilla – La Mancha and Región de Murcia (both with 28).


Comunitat Valenciana (21.8%), Canarias (21.7%) and Aragón (19.6%) had the highest annual rates in the number of mercantile companies created. In turn, Castilla-La Mancha (-8.9%), Illes Balears (-8.4%) and Cantabria (-4.8%) registered the smallest decreases.





Regarding the mercantile companies dissolved, the highest rates were recorded in Castilla y León (78.2%), Extremadura (43.5%) and Aragón (35.5%). In turn, Comunidad Foral de Navarra (-66.7%), Cataluña (-47.9%) and Región de Murcia (-47.2%) registered the greatest decreases.

#### Revision and updating of data

Data for 2023 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for February 2024 is published, the finalized data for the same month in 2023 will be released.

## Methodological note

The Mercantile Companies Statistics was created by Order of 30 December 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

**Population scope**: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month.

Reference period of the information: the calendar month

Collection method: administrative records.
