Mercantile Companies Statistics (MC)
April 2018. Provisional data

In April 8,817 mercantile companies are created, 13.2% more than in the same month of 2017 and 1,483 are dissolved, 12.6% more

Comunidad Foral de Navarra (41.8%), Castilla-La Mancha (36.0%) and Región de Murcia (35.4%) are the Autonomous Communities with the greatest business dynamism¹

In April, 8,817 mercantile companies were created, 13.2% more than in the same month of 2017. The subscribed capital for their constitution exceeded 433 million euros, with an annual increase of 43.9%. The average subscribed capital (49,110 euros) increased by 27.1%.

On the other hand, in April, 2,449 mercantile companies increased their capital, 17.9% more than in the same month of 2017. The capital subscribed in the increases grew by 44.0% and exceeded 2,342 million euros. The average subscribed capital in these transactions (956,513 euros) increased by 22.2% in the annual rate.

The number of mercantile companies dissolved in April was 1,483, 12.6% more than in the same month of 2017. Of these, 77.5% did so voluntarily, 5.6% due to mergers and the remaining 16.9% for other reasons.


¹ Business dynamism: Performance of the number of mercantile companies, understood as the annual variation rate of the creation of mercantile companies.

Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between March and April in the last five years. In 2018, the monthly variation of the number of companies created was -4.9% and that of the companies dissolved was -85.6%.

Results by main economic activity

20.5% of the mercantile companies created in April corresponded to *Trade* and 15.1% to *Construction*. Regarding the dissolved companies, 21.7% corresponded to *Trade* and 17.9% to *Construction*.

The activity with the greatest net balance of mercantile companies created in April 2018 was *Trade*, with 1,486.

On the contrary, *Transport and storage* registered the lowest net balance, with 258 companies created.


**Net balance of mercantile companies created by main economic activity

The economic activity with the greatest subscribed capital of mercantile companies created was *Real estate, financial and insurance activities*, with 233.60 million euros.

In turn, *Information and communications* presented the lowest capital subscribed, with 3.46 million euros.

Results by Autonomous Communities

The Autonomous Communities with the greatest number of mercantile companies created in April were Comunidad de Madrid (1,978), Cataluña (1,618) and Andalucía (1,564).

In turn, the Autonomous Communities where less mercantile companies were created were La Rioja (33), Comunidad Foral de Navarra (78) and Cantabria (84).

Regarding the dissolved mercantile companies, the ones that registered the highest number were Comunidad de Madrid (434), Andalucía (252) and Cataluña (131).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (3), La Rioja (8) and Extremadura and Región de Murcia (both with 19).


In terms of annual variation of the number of mercantile companies created, Comunidad Foral de Navarra (41.8%), Castilla-La Mancha (36.0%) and Región de Murcia (35.4%) recorded the greatest increases.

On the other hand, Extremadura (-24.0%) and Principado de Asturias (-21.3%) were the only Autonomous Communities with negative annual rates.

Regarding the mercantile companies dissolved, the highest rates were recorded in Principado de Asturias (59.1%), Castilla-La Mancha (44.8%) and Cantabria (40.0%).

In turn, those with the highest decreases were Comunidad Foral de Navarra (-57.1%), Extremadura (-20.8%) and Comunitat Valenciana (-15.7%).
