Mercantile Companies Statistics

June 2007. *Provisional data*

The number of mercantile companies created in June decreases 9.2% with respect to the same month of 2006

The interannual rate for the number of mercantile companies dissolved grows 55%

11,986 mercantile companies were created in June, 9.2% less than in the same month of 2006. The capital subscribed for their constitution reached almost 806 million euros, 5.3% more than in June of the previous year. In turn, **the average capital subscribed registered an interannual increase of 16%.**

On the other hand, in June, 3,539 mercantile societies increased their capital, 2.6% more than the same month of 2006. The capital subscribed in the increases registered an interannual decreased rate of 22.2% and reached almost 3,249 million euros. The average capital subscribed in these operations registered an interannual decrease of 24.1%.

The number of dissolved companies in June was 1,158, which implies 55% more than in the same month of 2006. Of these, 85.5% did so voluntarily, 7.5% due to mergers and the remaining 7% for other reasons.

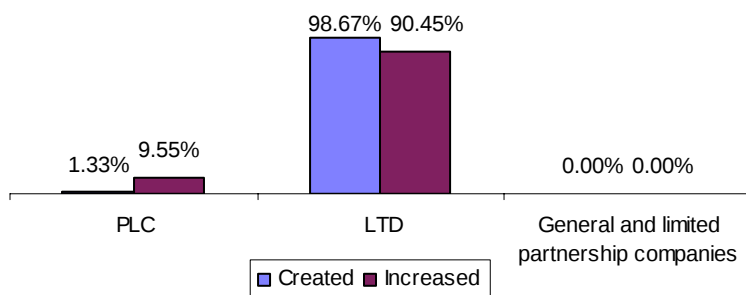

Private limited companies represent 98.7% of the companies created in June 2007 and 90.5% of those increasing their capital

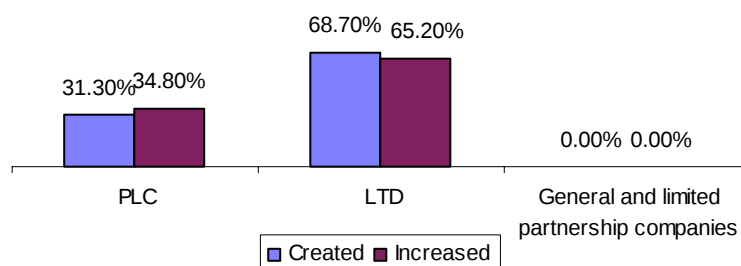
Out of the 11,986 mercantile companies created in the month of June, 98.7% were private limited companies and 1.3% were public limited companies. Out of the 3,539 companies that increased their capital, 90.5% were private limited companies and 9.5% were public limited companies.

68.7% of the capital registered by the mercantile companies created was subscribed by private limited companies and 31.3% by public limited companies. Regarding the capital subscribed in capital increases, 65.2% corresponded to private limited companies and 34.8% to public limited companies.

The interannual rate of the number of public limited companies created decreases 30% in June, and that of private limited companies decreases 8.9%. Regarding companies increasing their capital, public limited companies decreased 3.2% and private limited companies increased 3.2%.

The capital subscribed by public limited companies created increased 136.3% with respect to June 2006 and that subscribed by private limited companies decreased 15.9%. Regarding the capital subscribed by companies increasing their capital, there was an decrease of 5.8% in the interannual rate for public limited companies and an decrease of 28.8% for private limited companies.

La Rioja has the greatest average capital in companies created and Cantabria in those increasing their capital

The Autonomous Community with the greatest average capital subscribed by mercantile companies created in June was La Rioja (247,902 euros). In contrast, Cantabria was the Community with the least average capital subscribed (11,897 euros).

Cantabria had the greatest average capital subscribed by companies increasing their capital (3,456,389 euros) and Castilla-La Mancha had the lowest (203,246 euros).

Andalucía accounts for 35% of the total capital subscribed by the companies created.

Of the total capital subscribed in the creation of mercantile companies in the month of June, Andalucía accounted for the highest percentage (35%). On the other end of the scale was Cantabria (0.1%).

Regarding the total capital subscribed by mercantile companies that increased their capital, Comunidad de Madrid had the highest percentage (29.7%) and La Rioja the lowest (0.2%).
