Mercantile Companies Statistics (MC) June 2020. Provisional data

In June, 6,733 mercantile companies were created, 77.7% more than in May. Of these, 23.4% have *Commerce* as their main activity

The number of mercantile companies created was 9.4% less than in the same month of 2019

The number of mercantile companies dissolved, 1,112, is 131.2% less than the previous month. Of these, 18.9% have *Commerce* as their main activity

In June, 6,733 mercantile companies were created, 9.4% less than in the same month of 2019. The share capital for their constitution exceeded 393 million Euros, with an annual increase of 37.2%. The average subscribed capital (58,400 euros) increased by 51.5%.

On the other hand, 1,935 mercantile companies increased their capital in June, 10.2% less than in the same month of 2019. The capital subscribed in the increases registered a decrease of 37.9% and exceeded 1,062 million euros. The average subscribed capital in these transactions (549,015 euros) decreased by 30.8% in the annual rate.

The number of mercantile companies dissolved in June was 1,112, indicating 11.4% less than in the same month of 2019. Of these, 73.4% did so voluntarily, 14.5% due to mergers and the remaining 12.1% for other reasons.

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between May and June in the last five years. In 2020, the monthly variation in the number of companies created was 77.7%, and 131.2% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved June variation is compared with May of the same year. Percentage




Results by main economic activity

Of the mercantile companies created in June, 23.4% corresponded to *Trade* and 14.3% to *Real estate, financial and insurance companies.* Regarding dissolved companies, 18.9% corresponded to *Trade* and 14.9% to *Construction*.

June 2020. Percentage




Mercantile companies dissolved by main economic activity








The economic activity with the largest subscribed capital of mercantile companies created was Transportation and storage, with 158.09¹ million euros. In turn, Information and communications presented the lowest subscribed capital, with 2.24 million.


Subscribed capital of mercantile companies created by main economic activity





In regard to the average subscribed capital of the mercantile companies created, Transportation and storage registered the highest, with 733,735 euros per company. In turn, Information and communications registered the lowest average subscribed capital, with 6,929 euros.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in June were Comunidad de Madrid (1,499), Cataluña (1,436), and Andalucía (1,192).

In turn, those in which the fewest mercantile companies have been created were La Rioja (27), Comunidad Foral de Navarra (47), and Cantabria (61).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (364), Andalucía (162) and Comunitat Valenciana (112).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra and La Rioja (both with four).




Extremadura (24,7%), Región de Murcia (12.2%) and Principado de Asturias (34.3%) registered the highest annual increases in the number of mercantile companies created. In turn, Canarias (-33.2%), La Rioja (-30.8%) and Comunidad Foral de Navarra (-27.7%) registered the highest decreases.

Regarding the mercantile companies dissolved, the highest rates were recorded Comunitat Valenciana (49.3%), Cantabria (30.8%) and Aragón (22.9%). In turn, Canarias (-36.2%), La Rioja (-33.3%) and Castilla - La Mancha (-32.0%) showed the greatest decreases.

Revision and updating of data

Press

Data for 2020 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for June 2021 are published, the final data for the same month of 2020 will be disseminated.

Methodological note

The Mercantile Companies Statistics (MCS) was created by Order of 30 September 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces.

Reference period of the results: the calendar month.

Reference period of the information: the calendar month.

Collection method: administrative records.
