Mercantile Companies Statistics July 2010. Provisional data

The number of mercantile companies created in July increases 9.2% as compared with the same month of 2009

The number of mercantile companies dissolved increases 9.2% in the interannual rate

6,683 mercantile companies were created in July, 9.2% more than in the same month of 2009, and 6.4% less than in June 2010. The capital subscribed for their constitution exceeded 398 million euros, 16.3% more than in July the previous year. The average capital subscribed (59,585 euros) registered an interannual increase of 6.6%.

In turn, in July, a total of 2,803 mercantile companies increased their capital, 1.6% more than in the same month of 2009. The capital subscribed in the increases registered an interannual increase of 99.9%, and exceeded 6,410 million euros. The average capital subscribed in these transactions (2,286,920 euros) recorded an interannual increase of 96.8%.

The number of companies dissolved in July was 1,185, indicating an interannual increase of 9.2%. Of these, 70.6% did so voluntarily, 11.7% due to mergers and the remaining 17.7% for other reasons.


Results by type of company

Out of the 6,683 mercantile companies created in the month of July, 98.9% were private limited companies and 1.1% were public limited companies. Out of the 2,803 companies that increased their capital, 89.8% were private limited companies and 10.2% were public limited companies.

93.7% of the capital registered by the mercantile companies created was subscribed by private limited companies, and 6.3% by public limited companies. Regarding the capital subscribed in capital increases, 47.5% corresponded to private limited companies, and 52.5% to public limited companies.

The interannual rate of the number of public limited companies created increased 12.1% in July, and the corresponding rate of private limited companies increased 9.1%. Considering the companies that increased their capital, the number of public limited companies increased 7.1%, and that of private limited companies increased 1.0%.

The capital subscribed by the public limited companies created decreased 53.7%, while the capital subscribed by private limited companies increased 29.6%, in interannual terms. As per the capital subscribed by the companies increasing their capital, the interannual rate for public limited companies increased 116.1%, and for private limited companies 84.8%.

Results by Autonomous Community

Comunitat Valenciana presented the greatest average capital subscribed by the mercantile companies created (with 128,206 euros) in July. Conversely, Illes Balears registered the least average capital subscribed (12,974 euros).

Pais Vasco recorded the greatest average capital subscribed by companies increasing their capital (13,036,192 euros), while Cantabria recorded the least average capital subscribed (81,923 euros).

Out of the total capital subscribed in the creation of mercantile companies during the month of July, Comunidad de Madrid accounted for the highest percentage (40.1%), while Cantabria recorded the lowest percentage (0.3%).

Regarding the total capital subscribed by the mercantile companies increasing their capital, Cataluña registered the highest percentage (39.4%), while La Rioja and Cantabria recorded the lowest (both with 0.0%).
