## **Mercantile Companies Statistics**

August 2012. Provisional data

# 5,466 mercantile companies are created in August and 1,300 mercantile companies dissolved are registered

## The Autonomous Communities with a greater business dynamisim\* are Cantabria (47.4%), La Rioja (31.8%) and Región de Murcia (21.4%)

5,466 mercantile companies were created in August, 3.0% more than in the same month of 2011, and 20.9% less than in July 2012. The capital subscribed for their constitution exceeded 419 million euros, representing an increase of 100.0% as compared with August of the previous year. The average capital subscribed (76,798 euros) registered an interannual increase of 94.3%.

On the other hand, 2,332 mercantile companies increased their capital in August, 9.5% less than in the same month of 2011. The capital subscribed in the increases registered an interannual decrease of 64.5%, and exceeded 3,481 million euros. The average capital subscribed in these transactions (1,492,854 euros) decreased 60.8%.

The number of companies dissolved in August was 1,300, indicating an interannual increase of 19.8%. Of these, 72.9% did so voluntarily, 8.3% due to mergers and the remaining 18.8% for other reasons.






#### Results by main economic activity and type of society

23.4% of the mercantile companies created in the month of August corresponded to *Trade* and 20.1% to *Construction and property development*.

Regarding the dissolved companies by economic activity, 21.3% corresponded to *Construction and property development* and 19.5% to *Trade*.

The economic activity with the greatest net rate of mercantile companies created is *Accomodation and catering* (4.5%). *Industry and Energy* presents the most negative rate (-9.4%).

#### **Results by Autonomous City and Community**

Press Release

Comunidad de Madrid and Cataluña presented the greatest number of mercantile companies created in August, with 1,031 and 1,022, respectively. In turn, the Autonomous Communities where less mercantile companies were created were La Rioja (29) and Comunidad Foral de Navarra (54).

In terms of annual variation of mercantile companies created, Cantabria registered the greatest interannual rate (47.4%), followed by La Rioja (31.8%), while those that presented the greatest decrease are Principado de Asturias (-14.1%) and Cataluña (-10.0%).

Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid and Andalucía, 265 and 211, respectively. On the other hand, the Autonomous Communities that presented the lower number of dissolutions are Región de Murcia (3) and La Rioja (8).

In terms of annual variation of mercantile companies dissolved, Castilla – La Mancha registered the greatest interannual rate (200.0%), followed by Cantabria (137.5%), while those that presented the greatest decrease are Región de Murcia (-50.0%) and País Vasco (-21.2%).

## Mercantile companies created and dissolved by autonomous cities and communities

#### Results by type of society

Press Release

The number of public limited companies created in August decreased 60.4% in annual terms, and the number of private limited companies increased 3.6%.

Regarding to companies that increased their capital, the number of public limited companies and private limited companies registered an annual decreased of 5.1% and 10.1%, respectively.

The capital registered by the mercantile companies created registered an annual increase of 9.0% in public limited companies and 113.3% in private limited companies. Regarding to the registered capital by companies that increased capital, public limited companies registered a decrease of 75.9% and private limited companies registered a decrease of 39.1%.
