Mercantile Companies Statistics (MC)

August 2013. Provisional data

5,679 mercantile companies are created in August, 3.8% more than the same month of the previous year, and 1,298 are dissolved, 1.4% less

The Autonomous Communities with the greatest business dynamism¹ are Principado de Asturias (21.9%), Cataluña (13.8%) and Comunidad de Madrid (7.4%)

5,679 mercantile companies were created in August, 3.8% more than in the same month of 2012. The capital subscribed for their constitution exceeded 698 million euros, representing an increase of 54.1%. The average capital subscribed (122,945 euros) increased 48.4% in its annual rate.

On the other hand, 2,176 mercantile companies increased their capital in August, 6.8% less than in the same month of 2012. The capital subscribed in the increases registered a 32.4% decrease and exceeded 2,353 million euros. The average capital subscribed in these transactions (1,081,459 euros) decreased 27.4% in the annual rate.

The number of mercantile companies dissolved in August was 1,298, 1.4% less, as compared with the same month of the previous year. Of these, 71.6% did so voluntarily, 6.8% due to mergers and the remaining 21.6% for other reasons.

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between July and August in the last five years. This year the monthly variation of the number of companies created was -29.5% and that of the companies dissolved was -29.8%.



Evolution of the monthly rate of mercantile companies created and dissolved (July variation as compared with August of the same year)

Results by main economic activity

22.4% of the mercantile companies created in August corresponded to *Trade* and 17.8% to *Construction*. Regarding the dissolved companies, *Construction* concentrated 22.4% and *Trade*, 20.6%.



The economic activity with greatest net balance of all the mercantile companies created was *Trade*, with 1,006 companies. *Agriculture and fishing* registered the lowest net balance, with 123 companies created.





The economic activity with the greatest capital subscribed of mercantile companies created was, *Industry and energy*, with 349.16 million euros. *Information and communications* registered the lowest capital, with 2.08 million euros.

Results by Autonomous Cities and Communities

In August, the Autonomous Communities with the greatest number of mercantile companies created were Cataluña (1,163) and Comunidad de Madrid (1,105). Conversely, La Rioja (27) and Cantabria (53) were the Autonomous Communities that created less mercantile companies.

Regarding the dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (307) and Andalucía (209). In turn, those registering the lowest number of dissolutions were Comunidad Foral de Navarra (4) and La Rioja (13).

In terms of annual variation of mercantile companies created, Principado de Asturias (21.9%), Cataluña (13.8%) and Comunidad de Madrid (7.4%) registered the greatest increases. Conversely, Extremadura (-16.7%) and Región de Murcia (-14.1%) registered the lowest annual rates.

Regarding the mercantile companies dissolved in August, Región de Murcia registered the greatest annual rate (366.7%), followed by La Rioja (62.5%). Conversely, Comunidad Foral de Navarra (–69.2%) and Extemadura (–45.2%) showed the lowest annual rates.
