Mercantile Companies Statistics (MC)

September 2022. Provisional data

In September, 6,838 mercantile companies were created, 3.3% more than in the same month of 2021.

The number of companies dissolved was 1,430, with an annual increase of 11.8%

In September, 6,838 mercantile companies were created, 3.3% more than in the same month of 2021. The share capital for their constitution exceeded 399 million Euros, with an annual increase of 77.3% The average subscribed capital (58,457 euros) increased by 71.7%.

In turn, in September, 1,935 mercantile companies increased their capital, 3.6% more than in the same month of 2021. The capital subscribed in the increases registered a decrease of 38.2% and reached 1,205 million euros. The average capital subscribed in these transactions (622,589 euros) decreased 40.3% in the annual rate.

The number of mercantile companies dissolved in September was 1,430, indicating 11.8% more than in the same month of 2021. Of these, 79.6% did so voluntarily, 9.2% due to mergers and the remaining 11.2% for other reasons.

Mercantile companies created, increasing their capital and dissolved September 2022



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between August and September in the last five years. In 2022, the monthly variation in the number of companies created was 15.8%, and -8.2% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved


September variation is compared with August of the same year Percentage




Results by main economic activity

Of the mercantile companies created in September, 19.4% corresponded to *Trade* and 16.7% to *Real estate, financial and insurance companies*. Regarding dissolved companies, 17.7% corresponded to *Trade* and 17.6% to *Construction*.

Mercantile companies created by main economic activity




Mercantile companies dissolved by main economic activity



The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 297.75 million euros. In turn, *Administrative and support service activities* registered the lowest capital, with 2.42 million.


Subscribed capital of mercantile companies created by main economic activity September 2022. Thousands of euros



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 260,741 euros per company. In turn, *Administrative and support service activities* registered the lowest, with 7,850 euros.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in September were Comunidad de Madrid (1,708), Cataluña (1,276), and Andalucía (1,212).

In turn, those with the lowest number of mercantile companies created were La Rioja (37), Cantabria (52) and Comunidad Foral de Navarra (53).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (476), Andalucía (248) and Comunitat Valenciana (120).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (five), La Rioja (nine) and Extremadura (13).




La Rioja (76.2%), Cataluña (16.0%) and Comunidad de Madrid (9.5%) had the highest annual rates in the number of mercantile companies created. In turn, Extremadura (-36.4%), Castilla y León (-27.2%) and Castilla–La Mancha (-22.9%) registered the highest decreases.

Regarding mercantile companies dissolved, the highest rates were recorded in Región de Murcia (85.7%), Andalucia (38.5%) and Comunidad de Madrid (30.8%). On the other hand, Extremadura (-43.5%), La Rioja (-35.7%) and Principado de Asturias (-20.0%) registered the greatest decreases.

Revision and updating of data

Data for 2022 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for September 2023 is published, the final data for the same month of 2022 will be disseminated.

Methodological note

The Mercantile Companies Statistics was created by Order of 30 December 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month.

Reference period of the information: the calendar month

Collection method: administrative records.
