Mercantile Companies Statistics October 2009. Provisional data

The number of mercantile companies created in October decreases 8.9% as compared with the same month of 2008

The number of mercantile companies dissolved increases 10.1% in the interannual rate

During the month of October, a total of 6,287 mercantile companies were created, 8.9% less than in the same month of 2008 and 17.7% more than in September 2009. The capital subscribed for their constitution reached almost 354 million euros, indicating a decrease of 41.8% as compared with October of the previous year. The average capital subscribed (56,296 euros) registered an interannual decrease of 36.1%.

On the other hand, during the month of October, 2,286 mercantile companies increased their capital, 27.0% less than for the same month of 2008. The capital subscribed in the increases recorded an interannual decrease of 24.5%, and exceeded 2,541 million euros. The average capital subscribed in these transactions (1,111,930 euros) increased 3.4% in interannual terms.

The number of companies dissolved in October was 1,394, indicating an interannual increase of 10.1%. Of these, 64.4% did so voluntarily, 23.8% due to mergers and the remaining 11.8% for other reasons.


Private limited companies account for 99.0% of the companies created, and 88.9% of those increasing their capital

Out of the 6,287 mercantile companies created in the month of October, 99.0% were private limited companies, and 1.0% were public limited companies. Out of the 2,286 companies that increased their capital, 88.9% were private limited companies and 11.1% were public limited companies.

82.7% of the capital registered by the mercantile companies created was subscribed by private limited companies, and 17.3% by public limited companies. Regarding the capital subscribed in capital increases, 62.7% corresponded to private limited companies, and 37.3% to public limited companies.



In October, the number of public limited companies created decreased 41.2% in the interannual rate, and the number of private limited companies created decreased 8.4%. Considering the companies that increased their capital, the number of public limited companies decreased 16.5%, and that of private limited companies did so by 28.1%.

The capital subscribed by the mercantile companies created decreased 34.6% in interannual terms in the case of the public limited companies, and 43.1% in the case of private limited companies. As per the capital subscribed by the companies that increased their capital, the interannual rate for public limited companies decreased 38.9%, while that for private limited companies decreased 12.2%.

Comunitat Valenciana registers the greatest average capital in companies created, and in companies increasing their capital

By Autonomous Community, Comunitat Valenciana presented the greatest average capital subscribed by the mercantile companies created in October (142,223 euros). Conversely, Comunidad Foral de Navarra registered the least average capital subscribed (7,969 euros). Comunitat Valenciana also had the greatest average capital subscribed by companies increasing capital (3,381,250 euros) and Cantabria had the least (154,944 euros).

Comunitat Valenciana accounts for 30.3% of the total capital subscribed by the companies created

Out of the total capital subscribed in the creation of mercantile companies in October, Comunitat Valenciana accounted for the highest percentage (30.3%), while Comunidad Foral de Navarra accounted for the lowest percentage (0.1%).

Regarding the total capital subscribed by the mercantile companies increasing their capital, Comunitat Valenciana also registered the highest percentage (30.3%), whilst Cantabria recorded the lowest (0.1%).
