October 2011. Provisional data

# The number of mercantile companies created in October increases 16.1% as compared with the same month of 2010

## The number of mercantile companies dissolved increases 8.8% in the interannual rate

6,378 mercantile companies were created in October, 16.1% more than in the same month of 2010, and 10.9% less than in September 2011. The capital subscribed for their constitution exceeded 311 million euros, 0.8% less than in October the previous year. The average capital subscribed (48,797 euros) registered an interannual decrease of 14.6%.

On the other hand, 2,493 mercantile companies increased their capital in October, 22.2% more than in the same month of 2010. The capital subscribed in the increases registered an interannual increase of 369.2%, and exceeded 6,262 million euros. The average capital subscribed in these transactions (2,511,725 euros) recorded an increase of 283.9%.

The number of companies dissolved in October was 1,427, indicating an interannual increase of 8.8%. Of these, 65.9% did so voluntarily, 14.6% due to mergers and the remaining 19.5% for other reasons.



#### Results by type of company

Out of the 6,378 mercantile companies created in the month of October, 99.2% were private limited companies and 0.8% were public limited companies. Out of the 2,493 companies that increased their capital, 89.9% were private limited companies and 10.1% were public limited companies.

89.3% of the capital registered by the mercantile companies created was subscribed by private limited companies, and 7.5% by public limited companies. Regarding the capital subscribed in capital increases, 35.1% corresponded to private limited companies, and 64.9% to public limited companies.



The interannual rate of the number of public limited companies decreased 15.8% in October, and the corresponding rate of private limited companies increased 16.5%. Considering the companies that increased their capital, the number of public limited companies registered an interannual increase of 21.3%, while that of private limited companies increased 22.3%.

The capital subscribed by the public limited companies created increased 23.2%, while the capital subscribed by private limited companies decreased 5.7%, in interannual terms. As per the capital subscribed by the companies increasing their capital, the interannual rate for public limited companies increased 843.3%, and the rate for private limited companies increased 142.9%.

#### **Results by Autonomous City and Community**

Comunidad Foral de Navarra presented the greatest average capital subscribed by the mercantile companies created in October, with 136,821 euros. Conversely, Canarias registered the least average capital subscribed (8,979 euros).

Galicia recorded the greatest average capital subscribed by companies increasing their capital (19,080,877 euros), while Comunidad Foral de Navarra recorded the least average capital subscribed (263,359 euros).

Out of the total capital subscribed in the creation of mercantile companies during the month of October, Comunidad de Madrid accounted for the highest percentage (38.1%), while La Rioja recorded the lowest percentage (0.2%).

Regarding the total capital subscribed by the mercantile companies increasing their capital, Galicia registered the highest percentage (42.1%), while Cantabria recorded the lowest (0.1%).
