Mercantile Companies Statistics (MC)

October 2021. Provisional data

7,348 mercantile companies were created in October, that is, 0.6% less than in the same month of 2020.

The number of companies dissolved was 1,760, with an annual increase of 10.8%

7,348 mercantile companies were created in October, that is, 0.6% less than in the same month of 2020. The share capital for their constitution exceeded 204 million Euros, with an annual decrease of 48.8% The average subscribed capital (27,778 euros) decreased by 48.5%.

On the other hand, 1,948 mercantile companies increased their capital in October, 6.2% less than in the same month of 2020. The capital subscribed in the increases registered a decrease of 37.2% and exceeded 1,353 million euros. The average capital subscribed in these transactions (694,590 euros) decreased 33.0% in the annual rate.

The number of companies dissolved in October was 1,760, that is, 10.8% more than in the same month of 2020. Of these, 69.2% did so voluntarily, 19.1% due to mergers and the remaining 11.7% for other reasons.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between September and October in the last five years. In 2021, the monthly variation in the number of companies created was 11.0%, and 37.6% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved


October variation is compared with September of the same year. Percentage




Results by main economic activity

Of the mercantile companies created in October, 21.1% corresponded to Trade and 16.2% to Real estate, financial and insurance companies. As for dissolved companies, 19.6% corresponded to *Trade* and 15.0% to *Construction*.

Mercantile companies created by main economic activity




Mercantile companies dissolved by main economic activity



The economic activity with the largest subscribed capital of mercantile companies created was Real estate, financial and insurance, with 107.20 million euros. In turn, Administrative and support service activities registered the lowest capital, with 1.89 million.


Subscribed capital of mercantile companies created by main economic activity October 2021. Thousands of euros



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 90,056 euros per company. In turn, *Administrative and support service activities* registered the lowest average subscribed capital, with 5,975 euros.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in October were Comunidad de Madrid (1,801), Cataluña (1,347), and Andalucía (1,202).

In turn, those with the lowest number of mercantile companies created were La Rioja (29), Cantabria (51) and Comunidad Foral de Navarra (65).

Regarding dissolved mercantile companies, the ones that registered the highest number were Comunidad de Madrid (668), Andalucía (252) and Cataluña (133).


In turn, those with the lowest number of dissolved companies were Comunidad Foral de Navarra (seven), La Rioja and Cantabria (both with 11).


Illes Balears (26.0%), Canarias (25.2%) and Cantabria (21.4%) had the highest annual rates in the number of mercantile companies created. In turn, Principado de Asturias (-23.3%), Extremadura (-19.4%) and Andalucia (-14.8%) registered the largest decreases.

In regards to dissolved merchantile companies, the highest rates were recorded in Asturias (105.3%), Comunidad de Madrid (38.0%) and Cantabria and La Rioja (22.2%). Conversely, Comunidad Foral de Navarra (-72.0%), Extremadura (-32.4%) and Canarias (-22.7%) showed the greatest decreases.

Revision and updating of data

2021 data is provisional and will be revised when the data for the same period of the following year is published. In other words, when the data for October 2022 are published, the final data for the same month of 2021 will be disseminated.

Methodological note

The Mercantile Companies Statistics (MCS) was created by Order of 30 October 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces.

Reference period of the results: the calendar month.

Reference period of the information: the calendar month.

Collection method: administrative records.
