Mercantile Companies Statistics (MC) October 2022. Provisional data

7,149 mercantile companies were created in October, that is, 2.7% less than in the same month of 2021.

The number of companies dissolved was 1,919, with an annual increase of 8.8%

A total of 7,149 mercantile companies were created in October, that is, 2.7% less than in the same month of 2021. The share capital for their constitution exceeded 192 million Euros, with an annual decrease of 5.8% The average subscribed capital (26,883 euros) decreased by 3.2%.

On the other hand, in October, 2,045 mercantile companies increased their capital, 5.0% more than in the same month of 2021. The capital subscribed in the increases registered a increase of 3.5% and reached 1,401 million euros. The average capital subscribed in these transactions (685,013 euros) decreased 1.4% in the annual rate.

The number of companies dissolved in October was 1,919, that is, 8.8% more than in the same month of 2021. Of these, 76.1% did so voluntarily, 11.6% due to mergers and the remaining 12.3% for other reasons.


Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of mercantile companies created and dissolved between September and October in the last five years. In 2022, the monthly variation in the number of companies created was 4.5%, and 34.2% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved October variation is compared with September of the same year Percentage




Results by main economic activity

Of the mercantile companies created in October, 19.0% corresponded to *Trade* and 16.9% to *Real estate, financial and insurance companies.* As for dissolved companies, 19.5% corresponded to *Real estate, finance and insurance* and 17.3% to *Trade*.

Mercantile companies created by main economic activity


October 2022. Percentage



The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 127.11 million euros. In turn, *Administrative and support service activities* registered the lowest capital, with 1.77 million.

Subscribed capital of mercantile companies created by main economic activity



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 105,207 euros per company. In turn, *Administrative and support service activities* registered the lowest, with 5,744 euros.

The Autonomous Communities with the greatest number of mercantile companies created in October were Comunidad de Madrid (1,655), Cataluña (1,415), and Andalucía (1,244).

In turn, those with the lowest number of mercantile companies created were La Rioja (27), Cantabria (50) and Comunidad Foral de Navarra (52).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (745), Andalucía (237) and Comunitat Valenciana (157).


In turn, those with the lowest number of dissolved companies were Comunidad Foral de Navarra (nine), La Rioja (14) and Cantabria (20).


País Vasco (23.4%), Cataluña (5.0%) and Andalucía (3.5%) had the highest annual rates in the number of mercantile companies created. In turn, Extremadura (-24.1%), Comunidad Foral de Navarra (-20.0%) and Región de Murcia (-18.0%) registered the largest decreases.

In regards to dissolved merchantile companies, the highest rates were recorded in Cantabria (81.8%), Región de Murcia (80.0%) and Aragón (72.2%). Conversely, the greatest decreases were registered in Galicia (-8.3%), Principado de Asturias (-7.7%) and Andalucia (-6.7%).

Revision and updating of data

Data for 2022 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for October 2023 is published, the final data for the same month of 2022 will be disseminated.

Methodological note

The Mercantile Companies Statistics was created by Order of 30 December 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month.

Reference period of the information: the calendar month

Collection method: administrative records.
