### Mercantile Companies Statistics (MC) October 2023. Provisional data

# In October, 8,291 mercantile companies were incorporated, 16.0% more than in the same month in 2022

# The number of companies dissolved was 1,884, with an annual decrease of 2.0%

In October, 8,291 mercantile companies were incorporated, 16.0% more than in the same month in 2022. The capital subscribed for their incorporation exceeded 335 million euros, with an annual decrease of 74.5%. The average subscribed capital (40,455 euros) increased by 50.5%.

Meanwhile, on October 2,125 mercantile companies increased their capital, 3.9% more than in the same month in 2022. The capital subscribed in the increases registered a fall of 6.6%, totalling 1,308 million euros. The average subscribed capital in these transactions (615,946 euros) decreased by 10.0% in the annual rate.

The number of mercantile companies dissolved in October was 1,884, 2.0% less than in the same month of 2022. Of these, 75.9% did so voluntarily, 14.8% due to mergers and the remaining 9.3% for other reasons.

# Mercantile companies created, increasing their capital and dissolved October 2023


### Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of mercantile companies incorporated and dissolved between September and October in the last five years. In 2023, the monthly variation in the number of companies incorporated was 23.1%, and 51.3% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved October variation is compared with September of the same year. Percentage




### Results by main economic activity principal

Of the mercantile companies incorporated in October, 19.5% were engaged in Trade and 17.0% were Property, financial and insurance companies. As for dissolved companies, 19.3% were Trade and 14.6% were Construction.


### Mercantile companies created by main economic activity

October 2023. Percentage






The economic activity with the largest subscribed capital of mercantile companies incorporated was *Real estate, financial and insurance*, with  $\in$ 200.87 million. In turn, *Administrative and support service activities* registered the lowest capital, with  $\in$ 3.58 million.

With regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with €142,512 per company. In turn, *Administrative and support service activities* registered the lowest, with €8,999.

### **Results by Autonomous Community**

The Autonomous Communities with the greatest number of mercantile companies incorporated in October were Comunidad de Madrid (1,986), Cataluña (1,662), and Andalucía (1,444).

In contrast, those in which the fewest mercantile companies were incorporated were La Rioja (18), Comunidad Foral de Navarra (45), and Cantabria (63).

The Autonomous Communities with the highest number of dissolved mercantile companies were Comunidad de Madrid (727), Andalucía (270) and Comunitat Valenciana (129).


Conversely, those with the lowest number of companies wound up were Comunidad Foral de Navarra (two), Cantabria (20) and La Rioja and Región de Murcia (both with 23).


Principado de Asturias (43.8%), Extremadura (33.3%) and Castilla-La Mancha (32.4%) had the highest annual rates in the number of mercantile companies created. In turn, La Rioja (-33.3%), Comunidad Foral de Navarra (-13.5%) and País Vasco (1.5%) recorded the lowest rates.

In terms of mercantile companies dissolved, the highest rates were recorded in La Rioja (64.3%), Castilla y León (31.9%) and Andalucía (13.9%). On the other hand, the largest decreases were recorded in Comunidad Foral de Navarra (-77.8%), Región de Murcia(-36.1%) and Castilla – La Mancha (-24.3%).

### Revision and updating of data

The data for 2023 are provisional and will be reviewed when the data for the same period next year are published. In other words, when the data for October 2024 are published, the final data for the same month in 2023 will be disseminated.

### Methodological note

The Mercantile Companies Statistics were created by Order of 30 April 1938. Their objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies incorporated, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: continuous monthly survey.

**Population scope:** set of companies registered in the Central Mercantile Register.

**Geographical scope**: the entire national territory, by Autonomous Communities and provinces.

**Reference period of the results**: the calendar month.

**Reference period of the information**: the calendar month.

Collection method: official records.
