Mercantile Companies Statistics (MC)

November 2021. Provisional data

In November, 8,177 mercantile companies were created, 11.4% more than in the same month of 2020.

The number of companies dissolved was 2,130, with an annual increase of 3.3%

In November, 8,177 mercantile companies were created, 11.4% more than in the same month of 2020. The share capital for their constitution exceeded 629 million Euros, with an annual increase of 71.3%. The average subscribed capital (77,029 euros) increased by 53.8%.

On the other hand, in November, 2,327 mercantile companies increased their capital, 14.1% more than in the same month of 2020. The capital subscribed in the increases grew 89.7% and exceeded 2,007 million euros. The average capital subscribed in these transactions (862,740 euros) increased 66.2% in the annual rate.

The number of mercantile companies dissolved in November was 2,130, 3.3% more than in the same month of 2020. Of these, 79.3% did so voluntarily, 12.5% due to mergers and the remaining 8.2% for other reasons.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between October and November in the last five years. In 2021, the monthly variation in the number of companies created was 11.3%, and 21.0% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved


November variation is compared with October of the same year. Percentage




Results by main economic activity

Of the mercantile companies created in November, 20.1% corresponded to *Trade* and 17.8% to Real estate, financial and insurance companies. As for dissolved companies, 19.7% corresponded to Trade and 17.9% to Construction.

Mercantile companies created by main economic activity




Mercantile companies dissolved by main economic activity




The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 487.79 million euros. In turn, *Administrative and support service activities* registered the lowest capital, with 2.38 million.

In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 335,136 euros per company. In turn, *Administrative and support service activities* registered the lowest average subscribed capital, with 7,108 euros.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in November were Comunidad de Madrid (1,852), Cataluña (1,560), and Andalucía (1,552).

In turn, those in which the fewest mercantile companies have been created were La Rioja (48), Comunidad Foral de Navarra (64), and Cantabria (74).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (704), Andalucía (319) and Comunitat Valenciana (187).


In turn, those with the lowest number of dissolved companies were Comunidad Foral de Navarra (four), La Rioja (15) and Cantabria (21).


La Rioja (71.4%), Illes Balears (39.1%) and Comunidad Foral de Navarra (36.2%) had the highest annual rates in the number of mercantile companies created. In turn, Castilla y León (-11.6%), Principado de Asturias (-6.3%) and Castilla - La Mancha (-5.3%) registered the highest decreases.

Regarding the mercantile companies dissolved, the highest rates were recorded in Región de Murcia (100.0%), Principado de Asturias and Aragón (both with 50.0%). Conversely, Comunidad Foral de Navarra (-42.9%), Extremadura (-25.0%) and Castilla - La Mancha (-21.6%) showed the greatest decreases.

Revision and updating of data

2021 data is provisional and will be revised when the data for the same period of the following year is published. In other words, when the data for November 2022 are published, the final data for the same month of 2021 will be disseminated.

Methodological note

The Mercantile Companies Statistics (MCS) was created by Order of 30 November 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces.

Reference period of the results: the calendar month.

Reference period of the information: the calendar month.

Collection method: administrative records.
