Unpaid Bills of Exchange Statistics
Year 2012. *Provisional data*


**The value of unpaid bills of exchange is 7,067 million euros in 2012,
3.1% lower compared with that of 2011**

3.7% of the value of expired bills are unpaid

The INE published for the first time, independently, an annual summary of the evolution of the Unpaid Bills of Exchange Statistics. The information used is based on the annual data of 2012, as well as in the evolution of the last five years.

In 2012, the number of returned unpaid bills of exchange reached 7,067 million euros, the lowest figure in the last five years, and a 3.1% lower with regards to that registered in 2011.

Value of unpaid bills by type of financial institution

Banks concentrated 65.5% of the total value of unpaid bills, followed by the Saving Banks (27.4%) and the Credit Unions (7.1%).


In 2012, 3.7% of the value of expired bills of exchange were unpaid.

From 2008 to 2012 Banks registered a percentage of the value of unpaid bills of exchange against expired bills lower than that of the Saving Banks and Credit Unions.

Number of unpaid bills by type of financial institution


In 2012, 4.2% of the expired bills of exchange were unpaid.

Banks presented a percentage of the number of unpaid bills of exchange against the number of expired (4.3) higher than the total (4.2%). However, the Saving Banks and the Credit Unions presented percentages lower than the total.

Average value of unpaid bills by type of financial institution

With regards to the average value of the unpaid bills of exchange, Banks (with 1,743 euros) presented a lower value than the total (1,791 euros). However, the Saving Banks (with 1,840 euros) and the Credit Unions (with 2,122 euros) presented higher values.


Value of unpaid bills by type of bill

During the 2008-2012 period, a decreasing tendency was observed in the value portfolio bills of exchange. However, the effects in the collection management showed an increasing tendency.


The Credit Unions (with a 90.9%) were the financial institutions with the higher proportion of the value portfolio of unpaid bills of exchange, ahead of the Credit Banks (77.2%) and the Banks (71.5%).

Banks (with 28.5%) were the financial institutions with the highest value in the proportion of unpaid bill in management, followed by the Saving Banks (22.8%) and the Credit Unions (9.1%)

% of the value of unpaid bills of exchange by type of bill and by type of financial institution





■ Value Portfolio bills of exchange ■ Value Debt collection management from clients

Geographical distribution of unpaid bills of exchange

In 2012, the Autonomous Community with the lowest percentage of the value of unpaid bills of exchange was Comunidad Foral de Navarra (2.9%). Illes Balears (5.4%) and Extremadura (5.3%) registered the highest percentage of unpaid bills of exchange against expired.

According to the annual variation rate, in 2012 Extremadura presented the highest decrease in the value of unpaid bills (-20.3%) and Cantabria the highest rate (11.8%).
