# **Unpaid Bills of Exchange Statistics**April 2012. *Provisional data*

# The number of unpaid bills of exchange increased 8.9% in April, as compared with the same month in 2011

## 4.1% of the total expired bills of exchange are unpaid

In April, the number of returned unpaid bills of exchange reached 331,121, representing a 8.9% increase with regard to the same month the previous year.


The value of these unpaid bills of exchange reached 646 million euros, a 20.1% increase as compared with April 2011.

The percentage of unpaid bills of exchange against expired bills of exchange reached 4.1%.

In April 2012, the average value of expired bills of exchange (2,025 euros) was higher than the average value of unpaid bills of exchange (1,952 euros).



#### Bills of exchange by financial institution

64.7% of expired bills of exchange in the month of April were processed by Banks. Savings Banks managed 29.1% and Credit Unions managed the remaining 6.2%.

The number of unpaid bills of exchange increased 26.3% in Credit Unions and 8.3% in Banks and 7.0% in Savings Banks.

The average value of unpaid bills of exchange was higher in Credit Unions (2,335 euros) than in Savings Banks (2,058 euros) and Banks (1,876 euros).

Banks were the financial institutions with the highest percentage of unpaid bills of exchange (with 4.2%), while Credit Unions had the lowest percentage of unpaid bills of exchange (3.7%).

#### Bills of exchange by type of bill and financial institution

66.4% of expired bills of exchange in the month of April were portfolio bills of exchange, while the remaining 33.6% were in debt collection management from clients.

The percentage of unpaid bills of exchange against expired bills of exchange was greater for portfolio bills of exchange (with 4.5%) than for bills of exchange in debt collection management from clients (with 3.3%).

Banks were the financial institutions with the highest percentage of unpaid portfolio bills of exchange (with 4.6%), likewise in debt collection management from clients (with 3.4%).

The average value of unpaid bills of exchange was greater for portfolio bills of exchange (2,036 euros) than for bills of exchange in debt collection management from clients (1,723 euros).

Credit Unions were the financial institutions with the greatest average value for unpaid portfolio bills of exchange (2,697 euros). In turn, Banks recorded the greatest average value for unpaid bills of exchange in debt collection management from clients (1,918 euros).

#### Geographical distribution of unpaid bills of exchange

The Autonomous Community with the highest percentage of unpaid bills of exchange against expired bills of exchange was Región de Murcia (with 5.1%).

Conversely, the Community with the lowest percentage of unpaid bills of exchange in March was Comunidad Foral de Navarra (with 2.8%).

Región de Murcia (with 3,273 euros) was the Autonomous Community with the highest average value of unpaid bills of exchange.

The Autonomous Community with the lowest average value of unpaid bills of exchange was Cataluña (with 1,351 euros).
