Unpaid Bills of Exchange Statistics May 2012. Provisional data

The number of unpaid bills of exchange decreased 0.8% in May, as compared with the same month in 2011

4.5% of the total expired bills of exchange are unpaid

In May, the number of returned unpaid bills of exchange reached 371,350 representing a 0.8% decrease with regard to the same month the previous year.

The value of these unpaid bills of exchange reached 653 million euros, a 0.5% increase as compared with May 2011.

Total unpaid and expired bills of exchange

The percentage of unpaid bills of exchange against expired bills of exchange reached 4.5%.

In May 2012, the average value of expired bills of exchange (1,970 euros) was higher than the average value of unpaid bills of exchange (1,759 euros).





Bills of exchange by financial institution

65.1% of expired bills of exchange in the month of May were processed by Banks. Savings Banks managed 28.4% and Credit Unions managed the remaining 6.5%.

The number of unpaid bills of exchange decreased 4.6% in Savings Banks and 1.2% in Banks. In contrast, increased 26.9% in Credit Unions.

Total unpaid bills of exchange by financial institution

The average value of unpaid bills of exchange was higher in Credit Unions (2,051 euros) than in Banks (1,749 euros) and Savings Banks (1,717 euros).

Banks were the financial institutions with the highest percentage of unpaid bills of exchange (with 4.6%).

Bills of exchange by type of bill and financial institution

Press Release

65.9% of expired bills of exchange in the month of May were portfolio bills of exchange, while the remaining 34.1% were in debt collection management from clients.

The percentage of unpaid bills of exchange against expired bills of exchange was greater for portfolio bills of exchange (with 5.0%) than for bills of exchange in debt collection management from clients (with 3.7%).

Banks were the financial institutions with the highest percentage of unpaid portfolio bills of exchange (with 5.1%). In turn, Savings Banks presented the greatest percentege in debt collection management from clients (with 3.8%).

The average value of unpaid bills of exchange was greater for portfolio bills of exchange (1,860 euros) than for bills of exchange in debt collection management from clients (1,496 euros).

Credit Unions were the financial institutions with the greatest average value for unpaid portfolio bills of exchange (2,466 euros). In turn, Banks recorded the greatest average value for unpaid bills of exchange in debt collection management from clients (1,730 euros).

Press Release

The Autonomous Community with the highest percentage of unpaid bills of exchange against expired bills of exchange was Región de Murcia (with 5.8%).

Conversely, the Community with the lowest percentage of unpaid bills of exchange in May was Comunidad Foral de Navarra (with 3.2%).

Cantabria (with 3,189 euros) was the Autonomous Community with the highest average value of unpaid bills of exchange.

The Autonomous Community with the lowest average value of unpaid bills of exchange was Cataluña (with 1,248 euros).
