**The annual rate of the value of unpaid bills of exchange decreases
19.6% in November**


3.7% of the total expired bills of exchange are unpaid

In November, the number of returned unpaid bills of exchange reached 502 million euros, representing a 19.6% decrease with regard to the same month the previous year.

Percentage of unpaid bills of exchange against expired bills of exchange




The percentage of unpaid bills of exchange against expired bills of exchange reached 3.4%, three tenths lower than that registered the previous month.

Monthly rate performance ¹

The monthly rate performance of the unpaid and expired bills of exchange, between October and November 2012 was –13.6%, the lowest in the last three years. In the case of expired bills of exchange, the monthly performance was –6.9%.

Evolution of the monthly variation (october-september) value of expired and unpaid bills of exchange



In November, 71.6% of the value of unpaid bills of exchange corresponded to portfolio bills of exchange and 28.4% to bills of exchange in debt collection management.

¹ In order to contribute to the analysis and interpretation of data, this graph has been added, of the monthly rate performance of unpaid and expired bills of exchange. The intermonthly rates of this type of series may have some degree of seasonal behaviour, therefore it is recommended that it be evaluated in relation to the item of data for the same month in previous years..

In November, the number of returned unpaid bills of exchange reached 316,505, representing a 7.4% decrease, as compared with the same month the previous year.



Geographical distribution of unpaid bills of exchange

The Autonomous Communities with the greatest annual decrease of the value of unpaid bills of exchange were Extremadura (-52.7%) and Illes Balears (-43.5%).

In turn, Comunidad de Madrid (6.2%) and La Rioja (3.5%) were the Autonomous Communities with the greatest annual variation of the value of unpaid bills of exchange were.



Andalucía (with 4.4%), Castilla-La Mancha and Extremadura (both with 4.3%) presented the highest percentage of value of unpaid bills of exchange against expired bills of exchange. In turn, Galicia and Comunidad Foral de Navarra (both with 2.9%) presented the lowest percentage.

In November 2012, the Autonomous Communities of Cataluña and Comunidad de Madrid accumulated 47.1% of the total of unpaid bills of exchange.
