
Bankruptcy Proceedings Statistics Third quarter of 2009. Provisional data

The number of debtors processed increases 29.0% in the Third quarter as compared with the same quarter of 2008

75.2% of companies declared bankrupt are concentrated in Construction and Property Development, Industry and Energy and Trade

During the third quarter of 2009 the number of debtors processed reached 1,095, representing a 29.0% increase as compared with the same quarter of 2008.

By type of bankruptcy, 1,042 were voluntary and 53 were necessary, implying interannual increases of 29.0% and 29.3%, respectively. Considering the type of proceedings, abbreviated proceedings increased 171.2% and ordinary proceedings decreased 79.8%.

Processed companies by legal nature and business volume interval

Of the 1,095 debtors processed in the third quarter, 909 were companies (individuals with business activity and corporations). 73.3% of the companies declared bankrupt were Private Limited Companies.




60.0% of the companies declared bankrupt were within the lowest business volume interval, less than two million euros, and were mainly Private Limited Companies.

89.3% of companies declared bankrupt during the third quarter of 2009 did not belong to any business group. Of the remaining companies declared bankrupt, 9.9% belonged to a Spanish group, and 0.8 % to a group under foreign control.

group and type of control




Companies declared bankrupt by economic activity and number of employees

31.9% of companies declared bankrupt carried out their main activity in Construction and Property development, 25.9% in Industry and Energy, and 17.4% in Trade.

Regarding the number of employees, 38.8% of the total number of companies declared bankupt were ranked within the range of 10 to 49 employees.



Geographical distribution of debtors processed

The Autonomous Communities of Cataluña, Comunitat Valenciana and Comunidad de Madrid accounted for 52.3% of the total debtors processed during the third quarter of 2009.

On the other hand, La Rioja and Extremadura were the Autonomous Communities with the fewest debtors processed.

Methodological note

New National Classification of Economic Activities 2009 (CNAE 2009)

The European Parliament and Council passed the new classification of economic activities for statistical purposes within the European Union, known as NACE Rev.2, on 20 December 2006, via Regulation (EC) no. 1893/2006.

In order to be able to adapt the European classification to their reality, each Member State has compiled national versions that are compatible with NACE Rev.2. The national version of NACE Rev.2 in Spain is CNAE 2009, passed by Royal Decree 475/2007, of 13 April 2007 (BOE of 28 April 2007).

The adaptation to the new classification has caused changes in the Services Sector Activity Indicators survey, specifically in one of the variables studied: main economic activity of the company declared bankrupt. For some activities, the new classification has only caused a change in code, and not in content; in other cases, however, some activities have changed to belong to different branches or sectors. Thus, to quote an example, Development and selling of real estate has moved from the Services sector to the Construction sector. Collection and treatment of wastewater has moved from the Services sector to the Industry sector. Conversely, Publishing has moved from Industry to Services.

In order to guarantee the comparability of the information over time, the INE will publish the retrospective series of the number of companies declared bankrupt by main economic activity in the new classification, CNAE.2009 in this new classification in INEBASE.
