Bankruptcy Proceedings Statistics
Year 2009 and fourth quarter of 2009. *Provisional data*

The number of debtors processed increases 79.6% in 2009 as compared with 2008

74.9% of companies declared bankrupt in 2009 are concentrated in construction and property development, industry and trade

The number of debtors processed was 5,922 in 2009, representing a 79.6% increase as compared with 2008.

By type of bankruptcy, 5,614 were voluntary (81.7% more than the previous year) and 308 were necessary (48.1% more).

Considering the type of proceeding, ordinary proceedings decreased 24.5%, whereas abbreviated proceedings increased 195.8%.


By type of company processed, the number of Individuals with business activity increased 102.3% in the interannual rate, the number of Public Limited Companies grew 76.6% and that of Private Limited Companies registered a 68.8% increase.

Most companies declared bankrupt were Private Limited Companies (73.8%).

Most companies declared bankrupt in 2009 are within the lowest turnover interval

62.3% of companies declared bankrupt in 2009 were within the lowest turnover interval (less than two million euros). Considering the legal form of the companies declared bankrupt, this section includes all Individuals with business activity, 65.6% of Private Limited Companies and 39.8% of Public Limited Companies.

Number of companies declared bankrupt by legal nature and turnover (million euros)




84.2% of debtors processed in the year 2009 are companies

Of the 5,922 debtors processed in the year 2009, 84.2% were companies (individuals with business activity and corporations).


74.9% of companies declared bankrupt were concentrated in the activities of construction and property development, industry and trade.

Of the total companies declared bankrupt, 8.0% had no employees, 38.1% had 10 to 49 employees and 3.7% had more than 100 employees.

Companies declared bankrupt by main activity




Companies declared bankrupt by employee bracket



Cataluña, the Community with the highest number of debtors processed in 2009

Cataluña was the Autonomous Community with the highest number of debtors processed (1,413) in the year 2009, followed by Comunidad de Madrid (878), Comunitat Valenciana (808) and Andalucía (623). These four Communities accounted for more than 62.9% of the total debtors processed.


The Communities with the lowest number of debtors processed in 2009 were La Rioja (47), Extremadura (61) and Comunidad Foral de Navarra (64).



The number of debtors processed increases 20.9% in the fourth quarter

In fourth quarter of 2009, the number of debtors processed reached 1,542, which implied a 20.9% increase as compared with the same quarter the previous year, and a 40.8% increase as compared with the third quarter of 2009.

By type of bankruptcy, 1,461 were voluntary (21.4% more than in the fourth quarter of 2008) and 81 were necessary (12.5% more). Considering the type of process, abbreviated proceedings increased 149.5%, while ordinary processes decreased 79.1%.

Of the 1,542 debtors processed in the fourth quarter, 1,305 were companies (individuals with business activity and corporations). The majority of companies declared bankrupt were Private Limited Companies (74.8%).

61.2% of companies declared bankrupt were within the lowest turnover interval (less than two million euros).

Companies declared bankrupt by economic activity and employee bracket

73.6% of companies declared bankrupt had as their main activity construction and property development, industry and trade.

Agriculture and fishing were the activities with the lowest number of bankruptcy proceedings (1.2% of the total).

Regarding employees, the brackets of 10 to 19 employees and 1 to 2 employees registered the highest number of companies declared bankrupt.

Cataluña, the Community with the most debtors processed in the fourth quarter

Cataluña was the Autonomous Community with the most debtors processed (379) in the fourth quarter of 2009, followed by Comunidad de Madrid (259), Comunitat Valenciana (215) and Andalucía (155).

In turn, Comunidad Foral de Navarra (9), La Rioja (11), Principado de Asturias and Extremadura (both with 16) showed the lowest number of debtors processed.

Methodological note

New National Classification of Economic Activities 2009 (CNAE 2009)

The European Parliament and Council passed the new classification of economic activities for statistical purposes within the European Union, known as NACE Rev.2, on 20 December 2006, via Regulation (EC) no. 1893/2006.

In order to be able to adapt the European classification to their reality, each Member State has compiled national versions that are compatible with NACE Rev.2. The national version of NACE Rev.2 in Spain is CNAE 2009, passed by Royal Decree 475/2007, of 13 April 2007 (BOE of 28 April 2007).

The adaptation to the new classification has caused changes in the Bankruptcy Proceedings Statistics, specifically in one of the variables studied: main economic activity of the company declared bankrupt. For some activities, the new classification has only caused a change in code, and not in content; in other cases, however, some activities have changed to belong to different branches or sectors. Thus, to quote an example, "Property development" has moved from the Services sector to the Construction sector. "Collection and treatment of wastewater" has moved from the Services sector to the Industry sector. Conversely, "Publishing" has moved from Industry to Services.

In order to guarantee the comparability of the information over time, the INE will publish the retrospective series of the number of companies declared bankrupt by main economic activity in the new classification, CNAE-2009 in this new classification in INEBASE.
