
The number of bankrupt debtors decreases its annual rate by 3.7% in the fourth quarter of 2018

The number of bankrupt debtors decreased by 2.1% for the year 2018 as a whole.

During the fourth quarter of 2018, the number of bankrupt debtors reached 1,489 representing a 3.7% decrease, as compared with the same period of the previous year.

By type of bankruptcy, 1,398 were voluntary (3.1% less than the fourth quarter of 2017) and 91 were necessary (12.5% less). Considering the type of procedure, ordinary procedures decreased 19.8%, and abbreviated procedures did so by 1.7%.



Evolution of the quarterly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the quarterly variation of the number of bankrupt debtors between the fourth and the third quarter in the last five years. In 2018 the quarterly rate was 38.0%, the highest for the period in question.

Bankrupt companies by legal nature and turnover bracket

Among the 1,489 bankrupt debtors in the fourth quarter, 1,087 were companies (natural persons with business activity and legal persons), and 402 were natural persons without business activity, representing 73.0% and 27.0%, respectively of the total debtors.

In the fourth quarter of 2018, the number of companies declared bankrupt decreased by 4.3%, as compared with the same period of the previous year.

By legal nature, 81.1% of bankrupt companies were Limited Liability Companies.

38.5% of bankrupt companies were within the lowest turnover bracket (up to 250,000 euros) and were mainly Limited Liability Companies.

Bankrupt companies by economic activity and number of employees

23.6% of bankrupt companies had *Trade* as their main economic activity and 15.1% had *Industry and energy*.

Regarding the number of employees, 56.2% of the total number of bankrupt companies had less than six employees. Among these, 31.6% had no employees.



Taking the total number of existing companies in each economic activity as a reference, 0.08% of *Industry and energy* companies initiated a bankruptcy proceeding during the fourth quarter, as compared with 0.003% of *Agriculture and fishing* companies.

By employee bracket, 0.20% of existing companies with 20-49 employees initiated a bankruptcy proceeding, as compared with 0.01% of companies without employees.


(Bankrupt companies / Total companies Dirce) by economic activity.

Bankrupt companies by age

22.8% of the total number of companies declared bankrupt during the fourth quarter were 20 years old or more. In turn, 22.6% were four years old or less.

25.6% of bankrupt companies with four or less years of age were in the *Trade* sector. On the other hand, 54.8% of bankrupt companies with 20 or more years of age were involved in *Trade* and *Industry and energy*.



Taking the stock of existing companies by age as a reference, 0.039% of those that were 20 years old or more were affected by a bankruptcy proceeding this quarter. However, 0.019% of total companies with up to four years old initiated a bankruptcy proceeding.



Annual variation of bankrupt debtors by Autonomous Community. 4th quarter 2018. Percentage




Results for the whole year 2018

In 2018 as a whole the number of bankrupt debtors was 5,635, a 2.1% decrease compared to 2017.

By type of bankruptcy, 5,287 were voluntary (1.5% less than in 2017) and 348 were necessary (9.1% less). Considering the type of procedure, ordinary procedures decreased by 14.4%, and abbreviated procedures did so by 0.3%.

Bankrupt companies by main economic activity

In 2018, 73.3% of bankrupt debtors were companies (individuals with business activity and legal persons).

By economic activity, *Trade* and *Construction* accounted for 37.9% of the total number of bankrupt companies in 2018.

Professional activities (-16.9%), *Other services* (-11.4%) and *Construction* (-4.3%) showed the greatest decreases in the number of bankrupt companies in 2018 as compared with the previous year.

In turn, *Transport and storage* (16.9%), *Agriculture and fishing* (9.3%) and *Accommodation and catering* (8.9%) registered the greatest increases.

Bankrupt companies by economic activity and age (years). Year 2018



Results by Autonomous Community

In 2018, the Autonomous Communities with the greatest number of bankrupt debtors were Cataluña (1,577), Comunidad de Madrid (941) and Comunitat Valenciana (756). These three Autonomous Communities accounted for 58.1% of the total of bankrupt debtors.

In turn, the Autonomous Community with the lowest number of bankrupt debtors was La Rioja (35).

Revision and updating of data

The data published today are provisional and will be reviewed in the third quarter of this year.

Methodological note

The objective of the **Bankruptcy Proceedings Statistics (BPS)** is to provide quarterly information on the number of bankrupt debtors, as well as on the type of bankruptcy (voluntary or necessary), on the type of procedure (ordinary or abbreviated) and on the existence of anticipated proposal for agreement and of its content (debt relief, grace period, debt relief and grace period or another proposal). The information is obtained through the judicial bulletins filled out by the Mercantile Courts, the Courts of First Instance and the Courts of First Instance and Trial with mercantile jurisdiction.

This statistics have been carried out since 2005 replacing the [Statistics of Suspension of Payments and Declarations of Bankruptcy](#), which ceased to be made with the entry into force on 1 September 2004 of the Organic Law 8/2003 for the Reform of Bankruptcy Proceedings and the Insolvency Act 22/2003.

Type of survey: continuous on a quarterly basis.

Population scope: all debtors who have entered into an arrangement with creditors by a judge.

Geographical scope: the entire national territory.

Reference period: the calendar quarter.

Collection method: from the bulletins filled out by the courts.
