
The number of bankrupt debtors increases its annual rate by 14.6% in the fourth quarter of 2019

The number of bankrupt debtors increased by 3.1% for the year 2019 as a whole.

During the fourth quarter of 2019, the number of bankrupt debtors reached 1,979 representing a 14.6% increase, as compared with the same period of the previous year.

By type of bankruptcy, 1,855 were voluntary (14.0% more than in the fourth quarter of 2018) and 124 were necessary (24.0% more). According to process type, abbreviated processes increased by 16.0%, while the ordinary processes did not experience variation.



Evolution of the quarterly rate

To contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of bankrupt debtors between the third and the fourth quarter in the last five years. In 2019, the quarterly rate was 43.0%.

Bankrupt companies by legal nature and turnover bracket

Among the 1,979 bankrupt debtors in the fourth quarter, 1,280 were companies (natural persons with business activity and legal persons), and 699 were natural persons without business activity, representing 64.7% and 35.3%, respectively of the total debtors.

In the fourth quarter of 2019, the number of companies declared bankrupt increased by 12.2%, as compared with the same period of the previous year.

By legal nature, 78.1% of bankrupt companies were Private Limited Companies.

36.5% of bankrupt companies were within the lowest turnover bracket (up to 250,000 euros) and were mainly Private Limited Companies.

Bankrupt companies by economic activity and number of employees

25.8% of bankrupt companies had *Trade* as their main economic activity.

Regarding the number of employees, 56.6% of the total number of bankrupt companies had less than six. Among these, 29.6% had no employees.

Bankrupt companies by seniority

19.1% of the total number of companies declared bankrupt during the fourth quarter had a seniority of 20 years or more. In turn, 27.3% were four years old or younger.

27.8% of bankrupt companies with four or less years of experience were in the *Trade* sector. On the other hand, 55.1% of bankrupt companies with 20 or more years of experience were involved in *Trade*, and in *Industry and energy*.






Results for the whole of year 2019

In 2019 as a whole the number of bankrupt debtors was 6,599, a 3.1% increase compared to 2018.

By type of bankruptcy, 6,200 were voluntary (3.3% more than in 2018) and 399 were necessary (1.3% more). According to process type, ordinary processes decreased 12.3%, while abbreviated processes increased by 4.9%.

Bankrupt companies by main economic activity

In 2019, 67.6% of bankrupt debtors were companies (individuals with business activity and corporations).

By economic activity, *Trade* and *Industry and energy* represented 38.0% of the total of companies declaring bankruptcy in 2019.

Construction (-15.7%), *Other services* (-4.3%) and *Administrative activities* (-2.1%) showed the greatest decrease in the number of companies declared bankrupt in 2019 in comparison to the previous year.

Conversely, *Hospitality* (18.3%), *Commerce* (12.5%) and *Industry and energy* (8.5%) registered the highest increases.

Bankrupt companies by economic activity and seniority

In 2019, 21.6% of the total number of bankrupt companies had a seniority of 20 years or more. In turn, 23.6% had a seniority of four years or less.

The economic activity with the greatest percentage of companies declared bankrupt with seniority of 20 years or more was *Trade* (29.4%).

Bankrupt companies by economic activity and seniority (years). Year 2019



Results by Autonomous Community

In 2019, the Autonomous Communities with the greatest number of bankrupt debtors were Cataluña (1,946), Comunidad de Madrid (1,038) and Comunitat Valenciana (904). These three Autonomous Communities accounted for 58.9% of the total of bankrupt debtors.

In turn, the Autonomous Community with the lowest number of bankrupt debtors was La Rioja (37).

Revision and updating of data

The data published today are provisional and will be reviewed in the third quarter of this year.

Methodological note

The objective of the **Bankruptcy Proceedings Statistics (BPS)** is to provide quarterly information on the number of bankrupt debtors, as well as on the type of bankruptcy (voluntary or necessary), on the type of procedure (ordinary or abbreviated) and on the existence of anticipated proposal for agreement and of its content (debt relief, grace period, debt relief and grace period or another proposal). The information is obtained through the judicial bulletins filled out by the Mercantile Courts, the Courts of First Instance and the Courts of First Instance and Trial with mercantile jurisdiction.

This statistics have been carried out since 2005 replacing the [Statistics of Suspension of Payments and Declarations of Bankruptcy](#), which ceased to be made with the entry into force on 1 September 2004 of the Organic Law 8/2003 for the Reform of Bankruptcy Proceedings and the Insolvency Act 22/2003.

Type of survey: continuous on a quarterly basis.

Population scope: all debtors who have entered into an arrangement with creditors by a judge.

Geographical scope: the entire national territory.

Reference period: the calendar quarter.

Collection method: from the bulletins filled out by the courts.
