Fourth quarter 2020 and year 2020. Provisional data


The number of bankrupt debtors increases its annual rate by 5.8% in the fourth quarter of 2020

The number of bankrupt debtors decreased by 13.6% for the year 2020 as a whole.

During the fourth quarter of 2020, the number of bankrupt debtors reached 2,428 representing a 5.8% increase, as compared with the same period of the previous year.

By type of bankruptcy, 2,344 were voluntary (8.8% more than the fourth quarter of 2019) and 84 were necessary (40.0% less). According to process type, ordinary processes decreased 30.1%, while abbreviated processes increased by 8.8%.

Evolution of the quarterly rate

To contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of bankrupt debtors between the third and the fourth quarter in the last five years. In 2020, the quarterly rate was 44.7%.

Bankrupt companies by legal nature and turnover bracket

Among the 2,428 bankrupt debtors in the fourth quarter, 1,383 were companies (natural persons with business activity and legal persons), and 1,045 were natural persons without business activity, representing 57.0% and 43.0%, respectively of the total debtors.

In the fourth quarter of 2020, the number of companies declared bankrupt increased by 0.3%, as compared with the same period of the previous year.

By legal nature, 77.8% of bankrupt companies were Private Limited Companies.

45.8% of bankrupt companies were within the lowest turnover bracket (up to 250,000 euros) and were mainly Private Limited Companies.

Bankrupt companies by economic activity and number of employees

17.6% of bankrupt companies had *Trade* as their main economic activity.

Regarding the number of employees, 58.9% of the total number of bankrupt companies had less than six. Among these, 29.8% had no employees.

Bankrupt companies by seniority

20.0% of the total number of companies declared bankrupt during the fourth quarter had a seniority of 20 years or more. In turn, 27.5% were four years old or younger.

19.7% of bankrupt companies with four or less years of experience were in the *Hotel, restaurants and catering* sector. On the other hand, 47.3% of bankrupt companies with 20 or more years of experience were involved in *Trade*, and in *Industry and energy*.

Results by Autonomous Community

In the 2020, the autonomous communities with the greatest number of bankrupt in the fourth quarter were Catalonia (788), Comunidad de Madrid (404) and Comunitat Valenciana (346), which accounted for 63.3% of all bankrupt debtors.






Results for the whole of year 2020

In 2020 as a whole the number of bankrupt debtors was 6,718, a 13.6% decrease compared to 2019.

By type of bankruptcy, 6,447 were voluntary (12.1% less than in 2019) and 271 were necessary (38.4% less). Considering the type of procedure, ordinary procedures decreased by 31.7%, and abbreviated procedures did so by 11.9%.

Bankrupt companies by main economic activity

In 2020, 61.0% of bankrupt debtors were companies (individuals with business activity and corporations).

By economic activity, *Trade and Industry and energy* represented 32.6% of the total of companies declaring bankruptcy in 2020.

Agriculture and fishing (-32.3%), *Trade* (-27.6%) and *Industry and Energy* (-23.1%) presented the greatest decreases among companies declared bankrupt in 2020 compared to the previous year.

On the contrary, *Hospitality* (35.6%) registered the highest increase.

Bankrupt companies by economic activity and seniority

In 2020, 20.8% of the total number of bankrupt companies had a seniority of 20 years or more. In turn, 24.1% had a seniority of four years or less.

The economic activity with the greatest percentage of companies declared bankrupt with seniority of 20 years or more was *Trade* (25.8%).

Bankrupt companies by economic activity and seniority (years). Year 2020



Results by Autonomous Community

In 2020, the Autonomous Communities with the greatest number of bankrupt debtors were Cataluña (2,003), Comunidad de Madrid (1,099) and Comunitat Valenciana (947). These three Autonomous Communities accounted for 60.3% of the total of bankrupt debtors.

In turn, the Autonomous Community with the lowest number of bankrupt debtors was Comunidad Foral de Navarra (33).

Revision and updating of data

The data published today are provisional and will be reviewed in the third quarter of 2021.

Methodological note

The objective of the **Bankruptcy Proceedings Statistics (BPS)** is to provide quarterly information on the number of bankrupt debtors, as well as on the type of bankruptcy (voluntary or necessary), on the type of procedure (ordinary or abbreviated) and on the existence of anticipated proposal for agreement and of its content (debt relief, grace period, debt relief and grace period or another proposal). The information is obtained through the judicial bulletins filled out by the Mercantile Courts, the Courts of First Instance and the Courts of First Instance and Trial with mercantile jurisdiction.

This statistics have been carried out since 2005 replacing the [Statistics of Suspension of Payments and Declarations of Bankruptcy](#), which ceased to be made with the entry into force on 1 September 2004 of the Organic Law 8/2003 for the Reform of Bankruptcy Proceedings and the Insolvency Act 22/2003.

According to the provisions of the National Statistical Plan 2021-2024, the Official College of Property and Mercantile Registrars of Spain will prepare the Statistics of the Bankruptcy Procedure as of the first quarter of 2021.

Type of survey: continuous on a quarterly basis.

Population scope: all debtors who have entered into an arrangement with creditors by a judge.

Geographical scope: the entire national territory.

Reference period: the calendar quarter.

Collection method: from the bulletins filled out by the courts.
